

Ordinance No. 221.

AN ORDINANCE providing for the repair and improvements of Streets and Sidewalks within the Town of Stayton; providing an appropriation therefor; authorizing acceptance of U. S. Government aid for such work; repealing other ordinances in conflict herewith; and declaring an emergency.

WHEREAS, the U. S. Government, through the Works Progress Administration has allocated to and offered to the Town of Stayton the sum of \$5185.00 for labor costs for the repair, improvement, and construction of streets and sidewalks within the Town; and

WHEREAS, such work is urgently needed in said Town;

THE TOWN OF STAYTON DO ORDAIN AS FOLLOWS:

Sec. 1. That such streets as the Council of the Town of Stayton shall from time to time designate, be repaired and improved by grading, gravelling, and draining, and that the grade thereof shall be uniform and made to conform, as nearly as practicable, with the grade of other streets in said Town.

Sec. 2. That there be constructed within the Town of Stayton, such sidewalks as the Council may from time to time designate.

Sec. 3. All sidewalks constructed pursuant to this ordinance shall be of concrete construction, except that the Council may authorize the construction of wooden walks in it's discretion; and all sidewalks so constructed shall be done according to the Council's specifications and only with the Council's permission, and shall conform as nearly as practicable, with the grade and alignment of sidewalks heretofore constructed within the Town.

Sec. 4. That no sidewalk shall be constructed pursuant to the terms of this ordinance, unless all materials used therein, shall be furnished and paid for by the owner of the property adjoining the sidewalk so constructed; provided, only, that the expense of furnishing the concrete mixer, and the cost of the form lumber for the concrete sidewalks, shall be paid by the Town of Stayton.

Sec. 5. The width of any sidewalk of whatever material, shall be as designated by the Council, but shall in no case be less than four (4) feet wide.

Sec. 6. That all of the work provided for herein, shall be under the direct supervision of the Street Commissioner, who shall keep the <sup>Mayor and</sup> Council informed of the progress thereof.

Sec. 7. That all ordinances, or parts of ordinances, in conflict herewith, be, and the same hereby are hereby repealed.

Sec. 8. That there is hereby appropriated from the general fund of the Town of Stayton, not otherwise appropriated, not to exceed \$2882.00 for furnishing the materials and supervision for street work, and for furnishing supervision, mixer, and form lumber for the sidewalk work.

Sec. 9. That the offer of the U. S. Government to furnish, through the W. P. A., the sum of \$5185.00 to be used for labor costs in such work, be, and the same hereby is accepted, and the Mayor, Recorder, and or Treasurer are hereby authorized to enter into the required agreement with such agency.

Sec. 10. That inasmuch as the terms of such W. P. A. offer require such work to commence immediately, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect immediately following it's passage by the Council and approval by the Mayor.
