

ORDINANCE No. 605

AN ORDINANCE SETTING AN ELECTION DATE TO SUBMIT TO THE VOTERS OF THE CITY OF STAYTON THE QUESTION OF WHETHER OR NOT THE CITY SHOULD ANNEX INTO THE STAYTON RURAL FIRE PROTECTION DISTRICT AND DECLARE AN EMERGENCY

WHEREAS, the City of Stayton, by Resolution No. 330, initiated annexation of the City to the Stayton Rural Fire Protection District and directed that an agreement be prepared between the City and the District, and

WHEREAS, the City of Stayton, by Resolution 336 delayed the setting of an election date for the proposed Fire District annexation until the election results of Ballot Measure 2 would become known after November 6, 1984, and a final draft of the said agreement could be prepared, and

WHEREAS, the agreement between the City of Stayton and the Stayton Rural Fire Protection District, taking into account the election results of Ballot Measure 2 and providing for an orderly transition of assets and responsibilities, has been formally approved by the City by Resolution No. _____,

NOW THEREFORE,

THE CITY OF STAYTON ORDAINS AS FOLLOWS:

Section 1. That the City is substantially surrounded by the Stayton Rural Fire Protection District.

Section 2. That the issue of whether or not the City of Stayton should annex into the Stayton Rural Fire Protection District is hereby submitted to the voters of the City of Stayton at an election to be held on the 26th day of March, 1985, between the hours of 8:00 a.m. and 8:00 p.m., Pacific Time, within the City at polling places to be designated by the Marion County Election Clerk.

Section 3. That the form in which said question shall be submitted to the electors of the City on the official ballot at the election shall be as follows:

Section 4. This Ordinance being necessary for the immediate preservation of the public peace, health, and safety, an emergency is declared to exist and this Ordinance shall take effect immediately upon passage by the Council and approval by the Mayor.



ANNEXATION OF CITY OF STAYTON INTO STAYTON RURAL FIRE DISTRICT

QUESTION: Shall the City of Stayton be annexed to the Stayton Rural Fire Protection District for fire protection and emergency medical services?

EXPLANATION: The City now provides fire protection and emergency medical services within the City limits. The Stayton Rural Fire Protection District provides these services within the limits of the District.

The proposed annexation would form one unit of government serving the entire area within the present City and District with fire and emergency medical coverage.

Money to operate the proposed District would come from tax assessments to property owners within the newly formed district.
