

RESOLUTION NO. 496

A RESOLUTION REPEALING STAYTON RESOLUTION NO. 483, AND ADOPTING FEES AND CHARGES FOR VARIOUS SERVICES.

WHEREAS, Resolution No. 483 classifies fees, charges, and bonded indebtedness as being subject or not being subject to the property tax limitations of Section 11(b), Article XI, of the Oregon Constitution; and

WHEREAS, the City of Stayton has determined the following fees, charges, and bonded indebtedness are classified as not being subject to the property tax limitations in Section 11(b), Article XI, of the Oregon Constitution; and

WHEREAS, the City of Stayton receives requests from citizens for administrative, library, and recreational services requiring the expenditure of personnel time and materials; and

WHEREAS, the City needs to charge fees sufficient to recover the cost in personnel time and materials to render the service requested;

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Stayton that the following fees will be charged for services:
