Homelessness Task Force Public Opinion Survey


The City of Stayton conducted an on-line survey of public opinion regarding the issues surrounding homelessness. The survey was open for responses for a three-week period. There was a total of 374 responses received.

Residence and information about respondents

The first several questions asked information about the respondents, including the location of their residence and whether they owned their own home or owned a business in Stayton.

Of the 374 respondents, 274 (73%) indicated they were Stayton residents.


Q1 Do you reside in the Stayton City limits?

The next question asked Stayton residents whether they owned or rented their own home. Although only 274 respondents indicated they were Stayton residents, 313 respondents answered this question. None of the respondents indicated that they were currently experiencing homelessness. There were 11 respondents who provided comments to this question. The complete comments are included at the end of this report.

Q2 If you are a Stayton resident, do you



According to Census data, roughly 50% of City residents are renters. Homeowners were proportionally overly represented in the respondents, with 87% of the respondents identifying as homeowners. However, in comparing the results of subsequent answers of those who indicated they are homeowners with all answers, there is not a significant difference in responses between homeowners and renter.

The next question asked non-residents if they lived in the Stayton area. Although only 100 respondents answered Question 1 indicating that they were non-residents, 210 respondents answered this question. Only 15 respondents indicated that they did not live in the Stayton area.


Q3 If not a Stayton resident, do you live in the Stayton vicinity


Attitudes around Homelessness and the Response to it

The remaining questions asked about respondents' attitudes regarding homelessness, the impacts on the community and the City's response to homelessness.

When asked by Question 5 to what degree they perceived homelessness to be an issue in Stayton, respondents were provided with five choices, ranging from "not an issue" to "a huge issue." These responses were scored from 0 to 4. Similar numbers of respondents indicated that homelessness is an issue but that they were not directly affected, that homelessness is an issue that affects them directly and homelessness is a huge issue, accounting for 84% of all responses. The average score of all responses was 2.6 out of 4.0. Only 2% of respondents thought that homelessness is not an issue or had no opinion.

Business owners were more likely to report that they are directly impacted by the homelessness issue than all respondents, with 41% responding that they directly affected and 32% indicating homelessness is a huge issue. The average score for business owners was 2.9 out of 4.0.


Q5 To what degree, do you perceive homelessness is an issue in Stayton?

Question 6 asked in which areas of the community homelessness is an issue, providing four options and an opportunity to identify other areas. More than 77% of respondents indicated that camping in parks is an issue and 75% of respondents indicated that sleeping in parks is an issue.

Q6 In what areas of our community do you see homelessness being an issue? (check all that apply)





There were 131 "Other" responses to this question. The word cloud below represents the frequency that key words were used in these responses, by presenting more frequently used words in a larger size. A complete list of the "Other" responses is provided at the end of this report.



The next question asked about respondents' interactions with homeless individuals. Respondents were allowed to select more than one choice, with a total of 403 responses provided. A plurality of 33% of respondents indicated that they had no interactions. Negative verbal interactions were reported by 27% of the respondents. Interactions that had been both positive and negative were reported by 26% of the respondents. Only 8% of respondents reported positive verbal interactions.

Q7 Have you personally had interactions with homeless individuals in Stayton? (check all that apply)





There were 53 "Other" responses, indicating that most of the respondents that selected "Other" also had chosen one of the specific responses as well. The word cloud below represents key words in the "Other" responses. A complete list of the "Other" responses is provided at the end of this report.

From a list of 11 possible concerns, including "no concern" and "other," respondents were asked by Question 8 to identify their top three concerns. The three that received the most responses were concerns about drug and alcohol use and paraphernalia (79%), concern about garbage and environmental impacts (74%), and concern that homeless individuals will commit crimes (63%). Only 1% of the responses expressed no concern. 24% of the responses were that homeless individuals are not getting adequate support and 19% of the responses were about the lack of local support services for persons experiencing homelessness.

Q8 What are your top three concerns about homelessness Stayton? (Check up to three choices)



There were 20 responses provided as "other." A complete list of the "Other" responses is provided at the end of this report.

Question 9 related information about recent court rulings and state law and then asked if Stayton should regulate the act of sitting, lying, sleeping, or keeping warm and dry outdoors on public property. Respondents overwhelmingly indicated that the City should, with more than 87% stating that the City should adopt some objectively reasonable measures.


Q9 There is case law from the 9th Circuit Court of Appeals that says that "Persons experiencing homelessness are entitled to take necessary minimal measures to keep themselves warm and dry while sleeping outside" and that cities violate the Eighth Amendment of the Federal Constitution if they punish a person for the mere act of sleeping outside or for sleeping in their vehicles at night when there is no other place in the city for them to go.Recent state laws require that any city or county law that regulates the acts of sitting, lying, sleeping or keeping warm and dry outdoors on public property that is open to the public must be objectively reasonable as to time, place and manner with regards to persons experiencing homelessness.Do you think that Stayton should regulate the act of sitting, lying, sleeping or keeping warm and dry outdoors on public property?

The next question asked those who had indicated that the City should adopt some objectively reasonable measures what those measures should be, providing seven options and an opportunity to supply an "other" response. Respondents could select more than one choice. There 325 respondents with a total of 471 responses. There were 145 "Other" responses provided. 37% of the responses chose allowing homeless individuals to sleep in their vehicles in public parking lots. 32% of the responses chose allowing homeless individuals to sleep in their vehicles on the street, provided the vehicles are moved at least every 72 hours. No other choice garnered more than 10% of the responses. A complete list of the "Other" responses is provided at the end of this report.

Q10 If you answered Question #9 above as yes, what objectively reasonable measures should the City have in place? (Select all that apply)



Q11 In which City parks should homeless individuals be allowed to sleep? (Choose all that apply)



Garbage and waste of reusable items such as blankets, coats, tarps, sleeping bags, etc. For example, one day downtown we witnessed a homeless woman stuffing a nice hefty sleeping bag into a public garbage can. Although I have not witnessed it, I have heard of cars being stolen from 2nd Street and things being stolen from people's boats and vehicles down by the river. I cannot say these are homeless people, but it could be so that they can get money for whatever their needs or wants may be. I realize that not all homeless people use drugs or alcohol but just may be down on their luck and other ways and unable to afford the high cost of housing.

By our once beautiful river and now it's trashed by the homeless population. And some of our side streets have rvs parked along the curb! That is unacceptable! We taxpayers don't get nothing for free and all that we have we have worked for!

Panhandling, dumping trash in the park and ride, and camping in their vehicles in our neighborhood and being told by the police to not approach the individuals because they are known to become violent.

On business fronts

Needles left behind

Parking campers and trailers on streets for weeks at a time

Sleeping or doing drugs in the alcove at the back of our business building & parking lot (off of 1st St)

Walking onto our personal property. Lots of homeless activity going to and from the bridge. Also, seems to be more activity at or by the cleaners as your heading south out of town.

Park and ride

"Other" responses to Question 7: Have you personally had interactions with homeless individuals in Stayton?

After hearing fighting between male and female in the woods next to river we no longer go there to pick wild blackberries

Tend to avoid them

Experienced some unpleasant yelling; was not sure how to react or what to do. Happened several time in Pioneer Park. Seemed unsafe for kids to be around.

I don't want to park my truck at the river access when it's got people living out of their cars there. Look at ring doorbell footage, lots more crime at night lately.

I have been in a building when a homeless individual entered and had interactions with others near me.

I try to avoid eye contact and verbal interactions

Found garbage, knives, and drug paraphernalia left in parks. Unable to use Jordan Bridge for family photos because of homeless sleeping on it.

Had help with yard work from a homeless individual

Only meth addicts. Not pleasant.

You've inappropriately excluded some qualified answers to this question by limiting the options to only verbal interactions. An interaction does not have to include a verbal conversation to have a negative personal effect.

At work, they steal, broken into my car and home

Had a woman try and enter my home called Linn County police and reported also had a homeless man around my property in the middle of the night and ran him off

Having to walk past them on streets and in front of library

have been asked for "spare money" to give homeless persons.

Dog loose

Mostly visual

Walking past. No interaction

Stolen pop cans from my back yard many times

Just said hello, my neighbor has a guest living in a car outside their home

Non verbal - I'm nervous walking in the parks and I have seen homeless in the park on Ida Steeet by the river

Also have received many complaints from other residents

Breaking into homes

The homeless that I have had interaction with are on some sort of drug or drunk and are not in a mental state to have a normal conversation

negative Physical interactions

At the Pioneer Park restroom while with small children

Observed concerning behavior likely mental health

Throwing rocks at vehicles in front of my business

almost daily never pleasant to ask a camper to move or not piss on my house

Overhearing yelling and foul language and staring at kids while at the park

A girl was tripping on drugs all day down the Main Street & made her way to Sublimity & laid in the middle of the road.

Yelled at for not giving money to a homeless man in front of dollar tree. Chased by crazy lady when I was trying to go in to Stayton post office. Man masturbating in park area behind library... it's gotten bad.

Theft

The pan handling, approaching my car to ask for money, walking out into traffic

Witnessed homeless bathing in creek

My children were begged for money from a person standing at a corner of a street. They proceeding with giving him money. We don't need our children growing up in a town where they are being guilted to giving money to a person who could get a job.

Have seen a gentleman throw garbage over a fence which was to our backyard.

One individual has a pit bull on leash in manned and crossed an intersection off Shaff road. I almost hit dog roaming street. Same guy and dog went into my daughter record store in town and was just sitting in there making it very uncomfortable for my daughter who works her store in the afternoon.

Nonverbal interactions. For example, seeing them sleeping in the parks--Pioneer and River front, walking in the park, loitering in the downtown area near bars/ taverns, weed shops, and parking in the parks and in the park and ride. I realize not all of these people are bad people who are houseless, but it can make you uncomfortable not knowing for sure who this person is you are nearby. We have seen a man walking around the town wielding some kind of long item as if you want to keep your distance to stay safe.

Have been victim of theft by a homeless individual from vehicle parked at our business.

Crossed paths with many without any interaction, kept to themselves.

Thru Service Integration and handing out information.

Stumbled across a fire they set next to the community center which could have caught the building on fire.

Personally I've been approached while in my vehicle

We have had homeless people living in their cars park in our neighborhood. When they moved on they left bags of garbage, including depends with feces, on the road where their car had been parked. In another incident homeless people were using the porta potty in the neighborhood park to have sex. This is 10 feet from a playground. The police were called multiple times and although contact was made no arrests happened.

Masturbating in public park

Homeless man camping by the library as well as walking with my son we felt threatened.

Been glared at. They've crossed the road without looking. Trash strewn around. Needles and trash - not safe for walking

The homeless ask me for money and they are more then capable of getting a job.

Homeless people yelling obscenities as we are walking downtown, riding bikes, or at a park

I would rather not have to have interactions

Trying to remove from business premises; trash & clothes left

Wouldn't say positive or negative, as the person was clearly under the influence of something, but was not being "negative"

Make me feel incredibly unsafe with 3 children in tow when we're out

"Other" responses to Question 8: What are your top three concerns about homelessness in Stayton?

The decline of what small town USA use to be. Stayton was a nice community but it is rapidly changing for the worse.

Actually concerned about all of the above. We don't need Stayton to turn into a Portland or Salem.

I am very concerned that our response as a society to homelessness shows a lack of respect for quality of life to our children. It is not appropriate as a society to ignore, overlook, make excuses for the poor choices or accidental circumstances that cause individuals to become homeless.

Vandalism, trash, etc

Hobby Hut crime; I have personally seen drug paraphernalia at the park

i have witnessed and called non emergency line many times re attempted break ins to snow peak lodge napa etc no one else lives here police response great but

Needles I'm afraid of their needles

I am concerned of how squatters has so many rights and the home owner can't do anything

I'm concerned programs are enabling and not getting to the root cause

I'm concerned about them committing non lodgable propert crimes, being left on the street or cited and released at the scene by law enforcement and then revitalizing other parties. An increase in homelessness will increase the mentally ill population seeking services at the santiam memorial hospital and untreated mentally ill persons will commit more crimes, there are many many many children who walk around our community and it makes it unsafe for them and an increased potential they will be victimized by homeless or mentally ill persons.

Allowing and accommodating the homelessness to sleep, eat, 'live' where ever they please is NOT the direction we should be moving. The 'Homeless' choose or destruct themselves to the point of homelessness. The issues runs far deeper though.

Loitering, theft of homes and stores and word getting out that city of Stayton doesn't do anything about this and homeless people start moving in.

I am concerned that homeless individuals do not know that local support is available.

listing this choice to 3, does not do justice to the impact of homelessness in our community. All of these issues are not only concerns but 10/10 impactful on our community

Literally could check every box here.

The homeless need to go away before Stayton looks like Portland

If not handled it will be a large scale issue

I'm concerned about a witch hunt of the homeless.

There is pretty much no sense in trying to come up with funding to get them services they need because they don't accept it and I think we can give them a free bus ride to Salem or Portland whichever they choose! There is nothing in stayton for them here. We are a small community and in my opinion we need to keep it that way!

Without knowing the full extent of the homeless population in our city, I would propose that if any of these objectively reasonable measures come to fruition, that would allow homeless or other vulnerable individuals in situations as such have access to reasonable resources. Such as, the expectation of taking care of their own trash and 'dumping'. Adhering to laws expected of a city resident that may not be experiencing homelessness. I understand for many different reasons an individual may become homeless. I don't believe it is the city's responsibility to provide a 'space' for these individuals, or to encourage a 'safe place' for these individuals to have their own 'community'. I would be in agreement with having a central area or space for individuals in these situations to have appropriate access to an area, to dispose of their personal trash. There are other areas of town where we can care for or make donations to homeless in our area. One area may be in close proximity to the DHS office, even by city hall or vacant looking areas down near the south side of town in the vacant looking areas behind the newer business across the street.

Help the ones that want help get into housing.

Responses to Question 13: Please provide any additional comments.

I think the city should work with organizations such as MWVCAA to create a structured plan with structured spaces for both sleeping and parking.

It appears Stayton is looking for ways to enable homelessness in our community. It is true there will always be homeless people. We should be addressing some of the causes or it will only get worse. Drugs and alcohol addictions are a main cause. This problem starts at our borders so Stayton cannot solve all of this problem. Perhaps Stayton can take a tougher stance on drugs and alcohol availability, distribution and use. Our schools need to be active in teaching kids the dangers and the morality issues. Can Stayton assist the Churches to create programs that help people get out of their addictions and help people make good decisions in life? It is not a homeless problem. It is a problem of the human heart and our governments are helping corrupt generations of people that result in poor choices that effect their lives and everyone else's lives around them, either directly or through tax money used to clean our environment up only to have more homeless move in and damage it again. This state by allowing legal drug use has resulted in more people coming here for the drugs and they do not care that they are homeless.

Parks mentioned above are for our children to have a safe place to play. We all have rights, but 1 group of people should not take thr rights of our children to have a safe clean place to play.

Homeless individuals have come into our office, unannounced, during business hours. Both times the individuals were not of sound mind, walking into areas not open to public, looking for food or other items. We serve an elderly clientele and have women in our front office that were made very uncomfortable and feared for their safety. As a town, we can't tolerate this public health and safety concern.

We need to protect common sense, families, and businesses. Once beautiful and prosperous, LA, SF, and Portland have become unsafe and undesirable cities. Strong measures should be taken to avoid such scenarios in our town.

It seems like these questions are allowing the problem to stick around. People are leaving Oregon because of this issue and people will leave stayton. We certainly will if the problem grows or continues. I work in salem as a firefighter and deal with this problem everyday I work. These people have mental and drug issues that stayton cannot support. We need to move them to a city that has the resources. Salem transports these people to santiam ER where they get discharged and stay in our community. I hate talking like this but I have experienced first hand what stayton will become if it continues like this.

Sleeping outside on a temporary should be permitted but camping or residing within the same outdoor location within a 24 hour period should be prohibited. The passing of handbills from a vehicle to a pedestrian or person outside of a vehicle within city limits on public streets should be prohibited. Persons seeking monetary donations should be required to register with the city, provide reasonable proof of legitimate civil service and be permitted with regulation on signage and location. Provide a temporary city approved camp site to individuals who volunteer to aid in cleaning of city facilities and parks.

The homeless should be offered help. Whether it's for drug or alcohol addiction or the need for education to get a job. Such as UGM. Enabling them to live on the streets does no one any good. Provide them with life skills and tools. If they do not accept they need to move on.

Outreach to kids to get them the help that they need and to insure their safety.

I have compassion for the homeless and wish their was a way to get them stable housing and mental health care. However, I am also concerned about the safety of my property and my family. There are frequently homeless sleeping in the alleyway behind my house and going through the trash, I'm leery about taking my kids to the parks due to witnessing violent episodes with homeless and drug paraphernalia left around. We've also experienced a homeless individual intentionally setting fire to a bush on our property (with eyewitness) only for that person to be booked and released, and walking by our house again within an hour. It's not a safe town anymore. I worry about my kid walking home from the bus stop downtown if she's going to be harassed or not. This is an issue.

To allow something is to except it. We need to offer them to stay at a shelter. Yes I understand we dont have that. Therefore they should go to a shelter.

Something need to be in force. I've kicked them off my property and there needs to be a high penalty for trespassing. Private property needs to mean something again. It is not ok

Homeless is Stayton has become out of control. We have had homeless living in our out building. I no longer feel safe in my home and have added extra security. I am very concerned about property value and Stayton is starting to become Salem. I know several people who have moved from Stayton due to theft. Every morning I get alerts from community groups regarding thefts and break ins that happened over night. Needles have been found in a box in our front driveway thrown out the window. Something has to change!

Thank you for asking for opinions of the community and surrounding communities. Please keep our parks safe and clean for the children of Stayton. Thank you.

If they are camping or parked in vehicle, they should be punished if they litter/leave trash everywhere.

Parks were purpose built as parks however they do currently seem to be the best solution available for the Homeless in the Stayton area. If they are allowed to be used long term by homeless, I think restrictions need to be made as to specific areas available and times of day that homeless can use parks as living quarters. Secondly, if homeless are to be given additional rights and protections by the City, I think they should be registered by the City. This would make them a more known factor. I also believe that before they can receive the new rights, they should have to provide at least three references of family or friends that are aware of their situation. Those contacts should be required to acknowledge their need for services and be points of contact for the City if necessary. Thank you for considering these suggestions as you deal with this important issue.

We have a teen center. We need a place for adults to seek shelter

More mental health assistance. And more low income housing availability. Better information availability for assistance, to help them .

I have seen drug use on the streets. I've been yelled at, cussed at, followed, etc. I'm a tax payer that no longer feels safe using the parks I help pay for.

Buy them bus tickets to Portland or California.

Obviously the task is more complex than the survey questions have covered. It appears as though you are trying to decide which park to convert into a homeless camp. Those parks in the less defined neighborhoods would be more ideal, but truthfully speaking does Stayton really have any of those? I have not been to Northslope park so it is not in my comparison. Of all the parks mentioned Pioneer park would be more ideal but isn't the city of Salem already housing homeless by the river? And what about all the funding that went into developing it as a city event park.

They should be relocated to an area with services for them, such as Salem, Eugene, or Portland. If they are not willing to use the resources that are available then they do not care to have help and we should not provide them. I have had several interactions with multiple of our homeless and have mentioned the above resources to each of them all met with a very brash attitude. I work for a fire department in the area and see this daily, a vast majority do not want help and are content with the ways they are living such as criminal activity, drug use, alcohol abuse, stealing, turning environments into trash sites. Give them an inch and they will take a mile. This needs to be handled quickly and sharply or it will result in a much bigger problem they are facing in larger areas.

If they're under the age of 18 there are more resources. I was homeless at 15. Stayed that way until I decided I wanted a better life. Measures such as 110, lax laws and lack of actual punishment is feeding the issue. Stayton is becoming over crowded and needs to address things like schools and road improvements. Salem and Portland make bad decisions and seem to have all the answers. They have the funding, ship the people into where they can get help.

If they are under 18 there are help options. They should not be allowed out on their own. If they refuse help they shouldn't be enabled otherwise.

Send the homeless to the Churches and the people who support them, send them elsewhere, they don't contribute to society, and make a mess for every one else, and now kids can't go to the park because there are homeless sleeping under the structure, and behind in the forest, and all the drugs and needles left everywhere, and the stealing has gotten so bad business are calling the Stayton police almost every day.

The people that continue to enable their behavior can house them and worry about them

There are plenty of programs available if someone wants help

People are discriminatory with what they don't know

We should, as a community, provide shelter, food, and basic human needs. My concern is the health and safety of law abiding tax payers. People stealing brazenly in the open at our community stores with no ramifications from law enforcement! We must maintain the Rule of Law.

We don't want Stayton to look like Salem. Parks are for the public to enjoy not trash and to be come unsafe.

The streets are not safe for the homeless or people who are not homeless. The amount of drug use being done in front of my small children is not ok. There are a lot of resources in the state for the homeless and as such they should be transported to Shelters

If under age 18 and unaccompanied, state should get involved to provide shelter through foster care.

our small town of Stayton a warm inviting place for homeless to come to and gather, THE MORE HOMELESS PERSONS WILL CONTINUE TO COME HERE, from outside areas, namely SALEM!!

Why is it that when I travel all throughout Montana and Idaho I literally see no signs of homelessness? No tents, no garbage and grocery carts strewn along the streets, no panhandlers at the freeway exits, no cardboard boxes on the sidewalks with sleeping feet sticking out, no unfortunate looking individuals walking around talking to themselves, waving their arms and are clearly "on something?" Yet, as soon as I cross the border back into Washington and Oregon, there it all is. And it gets worse with every passing month. What do large cities like Boise and Missoula do to prevent homelessness? Our city needs to make living homeless less desirable than not living homeless. The only way I can see to do that is to enforce all the common sense laws and limits possible to discourage this. As well as having services available to those willing to seek help. Maybe some people would actually benefit from jail time and have an opportunity to get clean? I would like to raise my children in a community where they can play at a park without having to leave because a belligerent man is crawling out from the corrugated culvert (tunnel) where he's been sleeping (the park behind the swimming pool), or have to witness a man who barley looks human (extreme lack of hygiene) stumble out from the bushes at Pioneer park swaying and falling down vomiting. It is very sad what we are witnessing and I don't suggest there are easy solutions. I don't have a lot of hope for the state of Oregon as a whole, but our town can do better than this. We have to do better than this for the sake of children and future society. Being strict on homelessness is not punishment, it's compassionate. More services are needed to track homeless people and assure safety for citizens and the homeless. threatening behavior should not be ignored and local ordinances enforced by the City of Stayton Police. Service links must be developed for mental health issues and other critical services.

Accommodations that support the continued use of illegal or regulated substances without any visible means of legally paying for this abuse should be actively discouraged and routed out of our area. Many of these individuals are abusive to themselves and others and should not be encouraged to continue their poor lifestyle and theft. Give people options for working, maintaining their sleeping quarters and watching out for others in similar circumstances. If they don't abide by common decency standards they should be moved out of our area, not to return. Give people a hand up not handouts. If they show efforts to make their situation/vicinity safer, cleaner and more positive then we should support that. Otherwise we will continue to see a spiral down for the whole community.

Please be proactive. Designate people to meet with them and work to solve their issues. Sanitation needs to be a huge concern. Youth should always be cared for. Please do not put regulations in place that attract large numbers from surrounding areas.

If they are underage, they should be taken to State agencies in charge of children services.

A lot of these individuals area able to work they just don't want to and want to live off the system. I have everyday communications with many of them and some have been this way for more than three years. They also don't pay tax's but expect certain benefits that raise taxes for those paying taxes. Everyone should pull their own and not expect the government to take care of them. As we the people are supposed to be the government and elected officials are supposed to be working to solve issues and make things better for all not just a chosen few.

And passing unenforceable laws or decriminalizing things that enable individuals to become homeless due to the circumstances they have come to be with.

I highly suggest incorporating additional community outreach agencies such as Northwest Human Services - HOAP, Be Bold Street Ministries and Church At The Park. Their knowledge and expertise in working through homeless issues is invaluable and would help our city formulate a more effective approach. They could also wind up being our partners in getting the homeless here plugged into services.

I think parks should be off limits. So many children play at our lovely parks and we don't want them exposed to drugs, alcohol, human feces, possible nudity, etc. There are hiking trails we haven't even been able to use because of the homeless. We do care about them, but they need to stay away from areas where children are.

There are so many jobs out there. I feel for the homeless but These homeless people can find jobs or chose this lifestyle. Their lifestyle shouldn't become my problem. I have never been without a job myself.

There use to only be about 3 homeless people I would see around town for years. Now the park and ride is their home base and I have multiple of them running around my neighborhood. I would like to see something be done about this

I see a man sitting at the entrance of bi mart and surrounding area begging for money. Then I sew him smoking Marijuana in plain site of middle school kids on their way to school. It's inappropriate and he should be talked to by police. If I'm seeing it just driving past so are others. Also the crime in the neighborhood by dairy queen has gotten out of control

The City can work around alot of these laws regarding where homeless people sleep. There are other issues they can enforce and prosecute the person for things like theft, vandalism, drug use, littering and defecating in public. Stayton police need to do more instead of sitting back and watching as these homeless camps get bigger and bigger. They City has to stay on top of these thing or it will get so out of control we will start to look like Salem and Portland.

I am unsure of the solution to homelessness in Stayton, but know the problem is getting worse.

If you allow and facilitate this behavior this town will turn into a toilet.

Measures should be enforceable and enforced. Also, is it possible for sleeping rough to be centralized and supervised?

Oregon as a national magnet for homeless migration has now pulled in small towns. Rural residents choose less access to urban recreation, less diverse medical care, resources, etc. because we prefer the safer atmosphere of a small town. I take my children to the park less & less often to avoid the drug impaired. I change dining plans downtown if someone is sleeping on the sidewalk nearby. Businesses are burned from warming fires, and stolen from in the thousands of dollars. This problem will worsen if we enable. Are state of Oregon funds available to transport homeless folks to existing shelters?

Mental health/shelter resources within the community may help some, but only if those affected will use them. The homeless with whom I have interacted, have been offered services and declined to use them.

Make a designated area, maybe within the community center or close to the police department where the homeless shelter at not obstructing call home businesses and family private homes

There needs to be a shelter where homeless can get food, sleep out of the weather and get the mental health and rehab services they so desperately need.

I feel that we should not offer services for homeless that enable them to remain homeless. There are plenty of services available for those who actually want to utilize them. I do not want Stayton to end up like Salem boot them back to Salem and get them out of our parks and streets. Let's see some police activity to get the out of here.

This survey seems very one-sided as to the issue of the homeless in the Stayton area.

This issue is larger than Stayton. Get state help!

I thought all parks were closed to the public after dark. Kids with no adult to care for them should be in foster care not alone and homeless. If the city wants to provide a place for homeless to park then they should make a parking lot for them so they can stay off the residential streets. They deserve a hand up not a hand out. Do something about property taxes so that rent can be lowered, then maybe people could afford to not be homeless.

If they would pick up after themselves, stop exposing themselves while going to the bathroom, stop acting like their tweaked out (drugs or mental problems.) When told no for hand outs, stop following the person begging at them or getting mad. This causes confrontation and somebody's going to get seriously hurt because of this.

If they were under 18 and not accompanied they could be in a group home/foster home.

I am far more concerned with the property values decreasing with the increase of low income/government subsidized housing in the form of apartment complexes coming into the community than the homeless issue. As a new community member and homeowner I'm disappointed to see a apartment complex go up down the street from the park where my kids play, as my parents would say "there goes the neighborhood"

The city is restricted by the states ridiculous laws. Look at Salem, Portland, etc. Stayton is turning into a haven for homelessness which places a burden on the cities finances and residents.

generally where there are homeless people there are drugs. I have walked in pioneer park and I see old needles laying on the ground. Does this seem like a good place for our children to play. If the city would like to create a place specifically for the homeless then go ahead. But our parks and public streets should not be something that we need to keep kids away from.

It's not safe and makes people uncomfortable for kids who go to parks to play, or family gatherings...there are shelters for this situation. Plus my tax dollars clean those parks and it's unfair that they can leave trash or belongings and not be responsible for it.

The state should have resources for anyone under the age of 18 to have food and shelter.

Do not allow homeless to sleep or camp in parks where kids will be!!! They should not be slowed to set up camp wherever they want. They make it disgusting and don't clean up after themselves.

We do not take our family to Pioneer Park anymore because of the homeless and drug abuse. I work in Portland and we do not want our community to end up like that. Our tax money should be used to help get these people treatment for whatever has led them to be living on the street. If they refuse the treatment they should not be allowed to stay.

If the child is alone, then a foster fare type of program is mandatory. Keep them from getting hurt by others that could be dangerous. If with a family, then McKinney Vento must come into play and local help is needed.

Keep homeless where cops can keep an eye on them, not where they can hide and be Nefarious. If they want help bus them to Salem where there are shelters available

If something isn't done this town will look like Portland and Salem in no time

We avoid some parks because of homeless persons and their drug use

Individuals under 18 need a safe place to sleep.

They need to be isolated in one area. They should not be allowed to park in vehicles and sleep in them on streets, in front of houses, etc. As home owners of purchase this property and we do not want nor will we tolerate a homeless person parking in front of our house? The city requires that homeowners maintain their yards, their sidewalks, and it's pretty hypocritical to require homeowners to pay to repair sidewalks and maintain their property while allowing homeless people to camp and trash anywhere they want

We need affordable housing not campgrounds for the homeless in city parks.

Under 18 should be mandated to get assistance.

Mental health, substance abuse and low income services are very much needed. At the same time, it's hard to help those who don't want help. I'm sick of the trash that's everywhere as well as public intoxication that has blighted our community.

I understand homelessness, what I don't understand is the garbage, human waste, drugs and stealing that comes with it. Many have resources available but choose not to use them.

This is a terrible situation, but I also don't want my tax dollars for parks and such to be abused by people... any people....... I as a general citizen could not get away with what we are allowing homeless people to do

The city needs to find resolutions for people who WANT help. If someone rejects assistance from the state, they need to move on and not stay here. Florida has laws against panhandling and you see virtually zero homeless people there. They stay where they continue to get handouts. They need to get clean and get a job, or go somewhere else. Send them to Portland.

People shouldn't have to be taking these types of surveys about oregon's homeless epidemic. Our local governments should've done something about it when the problem started. Instead they haven't done anything for years.

Get the homeless out of our city. Stop catering to them. If this is the choice they are making, it shouldn't impact those us of who pay our taxes and abide by the laws. I'm so tired of our state encouraging homelessness. There's no reason for them to work when it's all handed to them.

We can not enable these people get them to Salem where they can get help and a job or mental help or drug treatment

My kids should be able to enjoy the parks and playgrounds as children should without having thier innocence destroyed listening to screaming and seeing people relieving themselves and acting like we are intruding on thier property when we try and play at the park or enjoy a picnic.

If you start providing too many services without requirements it becomes enabling behavior. Build the industry and it will become permanent

Sadly, with homelessness comes crime, drugs and garbage. It's the sad reality. It's unsafe to go to the city parks, or downtown and if it continues to get worse, my family won't be able to enjoy those areas. We do not want Stayton to look like Salem. They need to get resources to help them in the bigger cities and move there.

We don't need Stayton turning into the Salem homeless situation that is grossly out of control. There are government agencies and resources in the state to help them. Stayton does not need to turn into a wasteland that Salem has. A shelter needs to be established and a safe parking lot utilized for these individuals with sanitary measures and facilities available.

We've seen the homeless population grow recently and have had many conversations in our family about why, and what to do. It seems like an impossible problem. We talk a lot about not making the 'choice' to be homeless a normal one. We understand people can easily be in a position that they don't have a home, but we hope that they are encouraged to find their footing and participate in the community.

I think there needs to be a zero tolerance. If there is litter even if it's not theirs they need to pick it up or get kicked out. If they are intoxicated or caught with drugs they need to get kicked out. No exception should be made for mental issues. The severe cases need to be dealt with by getting help. How? That's hard to say for me but we can't tolerate or we just enable and the problem grows. It's tough love. Hopeful there are services that get developed to help rehabilitate people or keep people from going down the path to begin with. The biggest impact is trying to prevent it from growing and letting it be accepted while working on a long term plan that is continually getting refined.

Homeless people dont want to be in shelters because they dont like rules,or they dont want to be apart from their significant other or pet.. .Refer the homeless persons to salem,OR and educate them on Arches,Simona place,the union gospel mission,safe sleep, lighthouse shelter,etc. I moved to this area to GET AWAY from transients once word spreads this area

is supportive of homeless people, they will come in drones and not stop!!!!

Allowing and accommodating the homeless population will only deteriorate the situation. Having a dedicated structure like an apartment building would be better! Getting them off the streets and out of the parks is the whole point, not allowing them to just 'live' anywhere they please. Obviously the problem runs much deeper, the state we live in can't seem to figure anything out other than self-destruction, and it affects EVERYONES life who lives here. I enjoy the outdoors and the parks and the whole point to go is to get away from people!

We need to start a homeless shelter that allows people to build their own homes and provide for the small community on the property. Grow food, sell stuff they make and stay clean and sober. End of story that's how you help someone giving them a hand up not a hand out!!!!!!

We need to keep the parks clean so people can enjoy without drug paraphernalia and the smell of human waste. Must keep them controlled like rodents.

Designating area where it is allowed to be overnight will allow enforcement officers to maintain and monitor. Maybe the answer is one park, but certainly not every where and any where.

Minors are go are homeless should be in a shelter or in foster care if there is no adult to provide for them.

IF WE ALLOW ENABLE THEM TO LIVE ON THE STREETS IN OUR TOWN MORE WILL COME AND THEY WILL NOT GET THE HELP THEY NEED AND WILL BECOME A BIGGER ISSUE

The homeless individual that was sleeping at my child's school didn't even know where he was or how he got there- he didn't even know why state he was in. He was high the last time he remembered getting on a bus. How does that even happen? But, it's certainly scary when they are sleeping it off under the shelter of a school.

We have a great number of homeless in our area with a lack of options and resources for these people. However most people in homelessness do not want help or take the resources that are available to them to get out of the situation they are in. Due to mental health, drugs etc and they are ok with how they live. After talking to multiple individuals most don't want to do better

We need to find a way to get these people out of our community

There are devices in place for those individual under 18 and experiencing homelessness, we need to be better at getting them in touch with those services. I own a business that looks directly at the back of the community center where people have been living. I have seen them use narcotics, drink alcohol, masturbate, urinate, lite a fire that could engulf the community center, and scream. It is a hindrance on my business, and makes my employees nervous and feel extremely vulnerable as they are leaving.

I don't want to see any homeless people on the streets. It brings garage to the streets, safety concerns for walking the streets with my kids, if you allow some more will come and stayton will turn into a hole of a town to live in!!

This crap has to stop. Stayton and sublimity used to be a great CLEAN town until all the liberals started moving here and turning this place into a complete shit hole. As I've said above if people feel sorry for them they can go stay at their house. The amount of theft and garbage around town has gone through the roof. This has to stop. Don't turn this great community into a slop hole like every other democratic ran city in this state.

Let the homeless sleep in their cars next to City Hall and the police station. I have been verbally harassed by a homeless person while walking in local parks and my young child was verbally harassed by a drugged up angry homeless lady sleeping in Pioneer Park. If we allow homeless a place to stay comfortably, they will not take the initiative to help themselves out of their situation. You will see crime rates and public safety at an all time high. Please consider transportation to Salem where these systems are already in place along with mental health resources.

Our community youth play at these parks. We hold baseball games at these parks. Come on Stayton....this is ridiculous to even think for one second that allowing this is a good idea. I pay a lot of taxes to live here and I certainly don't want to financially contribute to cleaning up the messes these people make. Once you make it known that homeless have so many "rights" in our area, you can expect 100 more homeless people to move in.

I feel that the homeless regardless of age need a safe place to exist and are given the opportunity for help whether it be drug rehab, a job, a chance to be off the streets and succeed.

Under age Youth should be taking to a facility that can provide them with needed services. I came from a large city that allowed homeless to linger throughout the city. There was parks taken over by homeless, drugs and mental cases not being tended too. I hate for this small community in Stayton to have to get to this point. Actions needs to be taking to avoid this.

Pan handling should also be curtailed and enforced. Stayton and surrounding areas do not have the physical or financial resources to adequately support homelessness. Whatever plan you come up with needs to steer the homeless to locations that can help them get out of homeless was not just band aid it with making it easier to stay homeless. The plan also has to support families and neighborhoods so they are not negatively impacted by homeless camping

There are options for homeless kids under 18 in Salem and through child protective services

For any minors, I feel the children's services division of the state of Oregon should become involved and provide and care for those individuals appropriately.

Please do not ruin this small town by creating a safe haven for the homeless population. Salem offers free services to homeless with Arches and UGM. This creates very large problems in the city of Salem and will only have the same effect here in our small community. At most, provide free transport vouchers to Salem so the homeless population can have access to these services there. DO NOT provide them here. It will only cause MORE homelessness.

I would suggest working with the schools, Teen Center and other resources to help teenagers experiencing homelessness. There are a number of folks in the area that might help shelter youth in such circumstances.

Children may need additional help and services.

So tired of going to Parks with my grandchildren and avoiding people sleeping on slides, on the covered bridge and next to park restrooms. If they are allowed to sleep in the parks, there should be a time for them to exit the park. Also, I live by the parking lot next to the pool. When people park and sleep on the other side of my hedge, I feel totally unsafe. Also, I'm tired of hearing how harmless these drug addicted homeless people are. They are on drugs and unpredictable. I want to know why anyone would come into a small community that doesn't have

services....

It is horrible that we have to answer these questions, I have never experienced homelessness and I don't know the negative impact my answers might cause for these people. Do I want to see them sleeping in our parks? No. But do they need a safe place to exist? Yes. And they should be treated like human beings, with compassion. Not like animals that are pests.

Keep them and their trash off the river and out of the parks

Clearly designate a portion of the park for camping. No camping elsewhere in the same park. Limit the number of days. Require them to place garbage properly. Team up with SOCC which provides a bus to weekly showers. Foursquare church does laundry and a meal.

The accumulation of garbage and destruction of property when homeless camps are permitted makes it unsafe for families to use public parks. We need a better solution for homelessness instead of allowing laws to be broken. Those that want help should receive it to get off the street. Those that choose the lifestyle should be held accountable for breaking the law.

Let's put the focus on finding safe, creative solutions to the homelessness and not on policing infractions.

If they are under the age of 18 they should be placed in an appropriate facility with the resources they need. If they are not accompanied by a guardian.

If a child is homeless and unaccompanied by a parent/guardian then they need to be collected by DHS so that they can receive services and be assigned an emergency foster placement.

Parks are not designed as "living" space. Designate a specific area known as a short term living space. People under 18 are still considered more nots and should be considered separately.

Sleeping in parks shouldn't even be an issue. We need to renovate and use some of our empty or abandoned buildings to give people experiencing homelessness a safe, warm place to sleep.

Since Stayton has no services for warming shelters, food, or social services an effective solution would be to work with relocating to an area that has theses services to get homeless back on their feet. The ones who don't want help tend to be the ones out at 2am going through cars, porches, and garbages cans leaving the garbage scattered.

defined areas must be provided to the homeless so they can be directed to that area rather than left to choose any public or private location

There needs to be a process to help homeless families with school age children to access the services the district offers. A lot of times they don't realize the school district can help if they have school aged children.

We don't have a lot of homeless people in Stayton, thankfully, but some of the few we have are not mentally well and cause scenes in public areas or even relieve themselves in places other than bathrooms. Sweet Home has built small houses/shelters for their homeless population. Would that be something that perhaps our High schools could build for a class project in shop class?

The state and cities waste more money on the homeless and expect the community to pay for all these programs that fo not work, hold them accountable just as you would a taxpayer. If I leave garbage in my yard i will get letters and fines. If I camp in my trailer in my driveway I will get fined. By allowing homeless to break the laws dose not help them it only let's them know they can keep up the behavior and acts they are currently doing.

If we do not get a hold on this issue, we are going to end up with the same large scale issue that is occurring in Salem.

If we continue to give, and give and give, they will continue to take, and take and take, and the problem will grow, and grow, and grow. Same action, same result.

I work in Salem near the Capitol and have experienced multiple negative interactions with homeless people. One tried to get into the backseat of a young co-worker's car. We've had to start keeping our building doors locked because so many were coming inside our building and causing problems. If the City of Stayton doesn't act, our workers and residents will have similar negative experiences.

People live here because they want away from the garbage happening in Salem. We pay to use our parks and they're dirty and unsafe. There are services out there but you have to be clean to get them. This is not a homeless problem, it's a DRUG problem!!

If you're so worried about people being homeless, give them a place to live.

I guess I don't want to punish homeless individuals, but I think there needs to be harsher laws. If we force them to get help - that seems like a better solution. They must check into a drug/alcohol rehab center. Or they must use resources provided by Salem nonprofits to get back on their feet. Catholic Community Services in Salem helps homeless people every day and has a wonderful track record.

Stayton has good connections with providing available resources to help. It is difficult to want to accommodate those who don't take advantage of said resources. I have seen more people parking in the grocery store parking lots overnight. I don't think that is an appropriate place as it is private property.

This is becoming a HUGE issue for safety our kids can no longer go to parks and or walk around like they used to. It is maddening to see what is happening!

If they will be allowed to sleep in a park, then they should be rounded up and not be able to spread out. And make sure they are not camping too close to neighborhoods or businesses. Keep their nastiness in one area, so if our city workers are the ones having to pick up after them then it's all in one park!

There is a huge difference in the homeless who want to change their behavior and the homeless who do not. Stayton/ Marion county needs to have a space for a shelter. Those who want to occupy the shelter and better themselves should be put to work for their stay. Once they show they are serious maybe get paid by the city and

work up to reduced housing and then to a home. But must make progress and stay clean. Those who do not wish to stay at the shelter and abide by the shelter rules or stay clean, must go else where, out of city limits.

Stop harassing the unhoused and running them "over the bridge" to Linn County. They are our problem. Provide safe places, and more affordable housing, and make sure that each individual is offered the services they need to get off the streets.

This is all wonderful as long as you do something about this rather than keep "meeting" about our options... I feel like things like this go nowhere .

While I have concerns for the homeless (depending on their circumstances which I understand is hard to monitor), I feel strongly that we should not be enabling/allowing the situation to continue with no consequences. The drug use/addiction factor is my biggest complaint. I don't know if the city can pass any stricter laws regarding 'allowable' drug use/possession than what state has now passed, but that has truly let the horse out of the barn and created huge ongoing problems.

Any of our city parks are just that. Google purpose of a city park and you will find habitat for many different animals. Places for recreational opportunities, not limited to governmental, religious or other celebrations that we all contribute to. City parks also can increase property value, attribute to local economies, even combat crime. We live in an area where we have our youth, kinder and younger, kinder to high school already struggling for safe space after school or during summer. Using or choosing a specific city park is absolutely not a good decision. I'm sorry to say that I don't have any type of specifically safe area ideas I can think of. I'm not sure financially how our city plans to spend or afford specific monies to afford to continue 'care' for the homeless. Such as the few ideas I have already suggested. What I see are ppl that have no where to go. Maybe individuals who need mental health care in order to heal.

Maybe some need health care dental emotional help in order to heal. Maybe some need basic living skills. All of those which we don't have access to in our community. So many options to consider. I wish the best to all who are experiencing these hardships chosen or otherwise.
