

ORDINANCE NO. 312

AN ORDINANCE to amend the Charter of the Town of Stayton for the purpose of enlarging the legally described boundary of the Town of Stayton by annexing the following described real property, to-wit:

Beginning at the point where the North line of Stayton-Mehama Road intersects the present East boundary of the City of Stayton, Marion County, Oregon as per the records on file at the office of the County Recorder, Salem, Oregon; thence on the Easterly projection of said North line to the West line of the recorded Plat of Green Acres Subdivision; thence Northerly on said West line to the Northwest corner of said subdivision; thence Northerly on the projection of said West line 203.0 feet; thence North 89° 10' East 647.16' to the North projection of the East boundary of above said Green Acres Subdivision; thence South 00°39' East on last said projection and the East line of said subdivision 1002.7 feet; thence North 89° 11' East 250.0 feet; thence South 00°39' East 413.0 feet to the South Boundary of the Stayton-Mehama Road; thence Westerly on the last said road South Boundary to the point of intersection with the present East Boundary of the City of Stayton; thence on the said city boundary North to the place of beginning.

By authorizing the Common Council to call a public hearing where said proposed annexation will be placed before the registered voters of the Town of Stayton so that their comments may be heard, and declaring an emergency.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE TOWN OF STAYTON, OREGON:

Section 1. That a special election for the proposed annexation is unnecessary; the written consent of two-thirds of the land owners in the said area representing two-thirds of the assessed valuation of said area having been submitted to the Common Council.

Section 2. That a public hearing will be held at 8:00 o'clock P. M. on the 5th day of February, 1962, at the City Hall, Stayton, Marion County, Oregon, for the purpose of placing before the registered voters of said town the said proposed annexation to the Town of Stayton of the following real property, to-wit:

Beginning at the point where the North line of Stayton-Mehama Road intersects the present East boundary of the City of Stayton, Marion County, Oregon as per the records on file at the office of County Recorder, Salem, Oregon; thence on the Easterly projection of said North line to the West line of the recorded Plat of Green Acres Subdivision; thence Northerly on said West line to the Northwest corner of said subdivision; thence Northerly on the projection of said West line 203.0 feet; thence North 89°10' East 647.16' to the North projection of the East boundary of above said Green Acres Subdivision; thence South 00°39' East on last said projection and the East line of said subdivision 1002.7 feet; thence North 89°11' East 250.0 feet; thence South 00°39' East 413.0 feet to the South boundary of the Stayton-Mehama Road; thence Westerly on the last said road South boundary to the point of intersection with the present East boundary of the City of Stayton; thence on the said city boundary North to the place of beginning.

Section 3. That the City Attorney is hereby directed to prepare and have posted, notices in five (5) public places, including the bulletin board at the City Hall as well as publishing said notices in The Stayton Mail, a newspaper of general circulation, for two (2) consecutive publications, said notice to be posted and publications to be completed not less than ten (10) nor more than thirty (30) days prior to the date of the public hearing as set forth herein.

Section 4. It is hereby adjudged and declared that existing conditions in the Town of Stayton are such that this ordinance is necessary for the immediate preservation of the public peace, health and safety and an emergency is hereby declared to exist, and this ordinance shall take effect and be in full force and effect from and after its passage.
