ORDINANCE NO. 131.

A Bill for an Ordinance to license, tax and regulate certain callings and occupations within the Town of Stayton, Oregon; prescribing the character of said licenses and the manner of issuing and collecting the same; fixing penalties and restrictions in relation thereto; and repealing all of Ordinances No. 9, 10, 13, 20, 26, 40, 77, 78, 82, 88, 95, 112, and all ordinances and parts of Ordinances in conflict herewith.

THE TOWN OF STAYTON DO ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any person, company or corporation to prosecute or carry on any calling or occupation within the Town of Stayton, Oregon, for which the terms of this Ordinance require the payment of a license, until such person, company or corporation shall have secured and paid for the license so prescribed for said calling or occupation, as hereinafter set forth.

Section 2. Each and every person or persons required by this Ordinance to pay for and secure a license for his, her or their calling or occupation, shall, before engaging in the same, pay to the Recorder of the Town of Stayton, Oregon, the sum or sums prescribed and fixed therein, as license fees, and upon payment of the license fee prescribed in this Ordinance, he or they shall receive from the Recorder of said Town a license to conduct the said calling or occupation so paid for, which said license shall show the name of the person or persons to whom the same is issued, the nature of the calling or occupation licensed, the amount paid as license fee therefor, and the time for which said license is issued.

Section 3. The following callings or occupations conducted or maintained within the Town of Stayton, Oregon, are hereby required to be, and are, licensed in the following sums and for the following terms:

Section 4. The proprietor, manager or agent of each and every circus, or menagerie, exhibiting in the Town of Stayton, Oregon, shall pay the following license fees:

For a one-ring circus, \$20.00 per day; for a two-ring circus, \$30.00 per day; for a three-ring circus, \$50.00 per day; and for each and every sideshow, \$5.00 per day; for each and every show exhibiting under a tent and not classed as a circus, but involving the display of trained animals in specific acts with adept human beings, \$20.00 per day, (save and except dog and pony shows); for every horse, dog and pony show exhibiting under a tent, \$25.00 per day; and for every menagerie of animals exhibiting under a tent, \$10.00 per day.

Section 5. All shows, amusement ventures and public performances given in and upon the streets and highways of the Town of Stayton, Oregon, as an attraction and auxiliary, to the public sale of any commodity, patent medicine, toy, novelty, or other thing usually peddled upon the streets pay a license fee as follows: For each and every person engaged with such public performance, or in the selling or peddling of such commodity or thing, the sum of \$5.00 for one day; \$25.00 for one week.

Section 6. The proprietor, manager or agent, of any public game or amusement, such as "flying horses", or "merry-go-round", "cane game", "spindle-wheel", "wheel-of-fortune", or "ballthrowing", or

"ring-throwing" game, or game similar thereto and not here specifically designated, shall pay a license fee of \$3.00 per day.

Section 7. The owner, keeper or agent of any billiard table, or pool table, or other table upon which any game is played, with ball and cue, in a public place in this town (whether said games are played by the habitues or customers of said public place for pay, cost or charge, or for amusement only and free of cost or charge) shall pay a license fee of \$20.00 per year for each and every table so kept and played upon in such public place; provided, that no greater sum than \$40.00 shall be collected for the tables in any one room in such public place.

Section 8. The proprietor, manager or agent of any bowling alley or shooting gallery shall pay a license fee of \$25.00 for one year and \$15.00 for six months; provided that no license shall issue in this behalf for less period than six months.

Section 9. Peddlers passing from place to place in the Town of Stayton, Oregon, on foot and not crying their wares, shall pay a license fee of \$10.00 for one week and \$2.00 for one day. Peddlers passing from place to place in the town of Stayton, Oregon, by vehicle drawn by one or more animals, and not crying their wares, shall pay a license fee of \$20.00 for one week, and \$5.00 for one day; provided that persons peddling newspapers, bibles and religious tracts, and farmers, gardeners and dairymen, peddling the products of their own farms, gardens and dairies, shall not be deemed to be peddlers under this Ordinance.

Section 10. The proprietor, manager or agent of any theater, show, concert or other traveling exhibition conducted in a public theater, hall or tent within the Town of Stayton, shall pay a license fee of not less than \$2.00 nor more than \$10.00 for each day or night.

Any person, firm or corporation violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor, and upon conviction before the recorder shall be fined in a sum not less than \$10.00 nor more than \$100.00.

Section 11. That Ordinances No. 9, 10, 13, 20, 26, 40, 77, 78, 82, 88, 95, 112, and all ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed.
