Subject: Open house to discuss the upcoming Safe Routes to School improvements.

Marion County has received state funds to design and construct pedestrian facilities along Shaff Road immediately south of Stayton Middle School. The project will construct a new sidewalk from the east end of the existing pedestrian path and extending to Gardner Avenue (approximately 300 feet), construct ADA compliant curb ramps for the east-west crossing of Gardner Avenue, and an upgraded, ADA compliant pedestrian crossing of Shaff Road on the east leg of the Gardner Avenue intersection that will also include rectangular rapid flashing beacons, signage, and surface markings to enhance crossing visibility and safety.

Shaff Road and Gardner Avenue will remain open during construction with flaggers directing traffic through the work area when needed. Construction is expected to be completed in the summer of 2023.

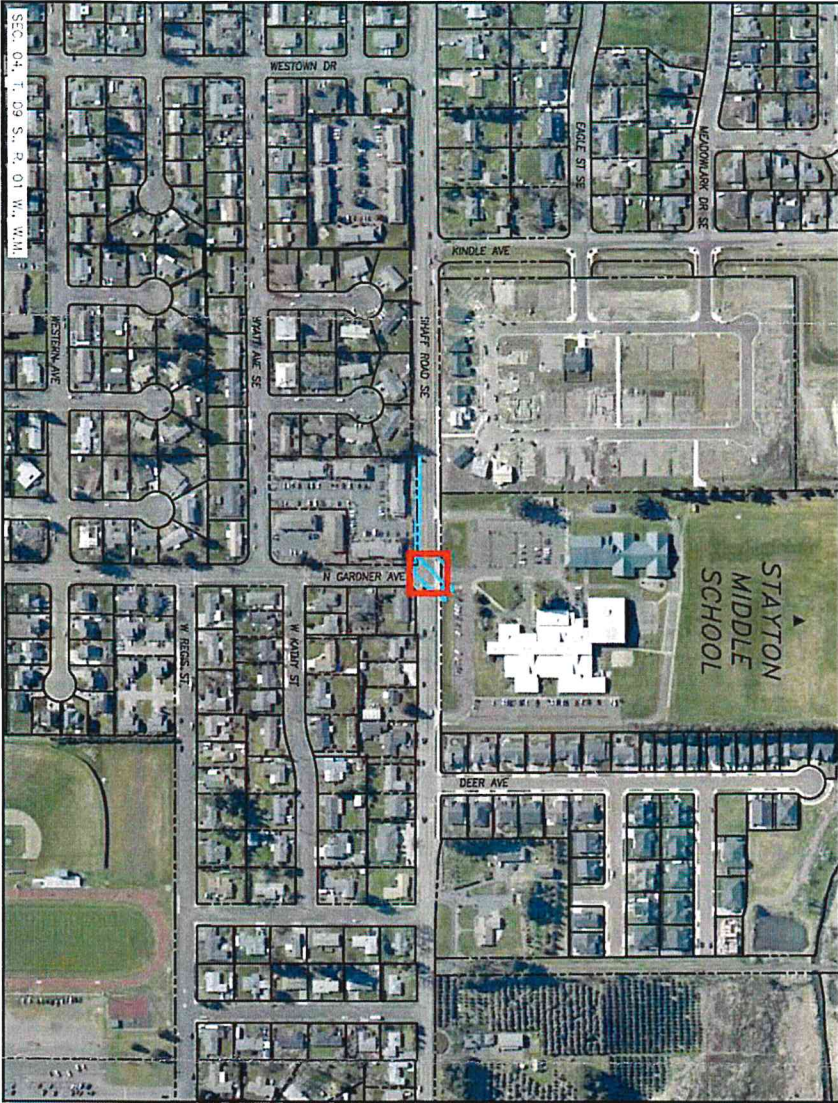

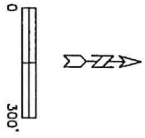
