ORDINANCE NO. 218.

AN ORDINANCE PROVIDING FOR THE REPAIR AND IMPROVEMENT OF STREETS AND OTHER PUBLIC PROPERTY, AND FOR DRAINAGE WORK WITHIN THE TOWN OF STAYTON; PROVIDING AN APPROP-BIATION THEREFOR; AUTHORIZING ACCEPTANCE OF U. S. GOVERNMENT AID FOR SUCH WORK; and DECLARING AN EMERGENCY.

WHEREAS, Many streets in the Town of Stayton are in urgent need of repair, and an extension of the present drainage system therein is urgently needed; and

WHEREAS, the U. S. Government, through the Works Progress Administration, has allocated and offered the sum of \$5020.00 to the Town of Stayton to be used in furnishing labor for such work:

THE TOWN OF STAYTON DO ORDAIN AS FOLLOWS:

- Sec. 1. That such streets as the Council may designate, be repaired and improved by grading, gravelling and draining, and that the grade thereof shall be uniform and conform, as nearly as practical, with the grade of other streets in said town.
- Sec. 2. That such drainage work as the Council may deem necessary, consisting of ditching and laying of tile and culverts, be done.
- Sec. 5. That such filling, grading and landscaping of the area surrounding the Town of Stayton water supply wells, be done as the Council shall deem necessary.
- Sec. 4. That the offer of the U. S. Government to furnish, through the W. P. A., the sum of \$5020.00, or such part thereof as may be required, for use in furtherance of such work, be, and the same hereby is accepted, and that the Mayor, Recorder and Treasurer are hereby authorized to enter into such agreement with the W. P. A. as may be required.
- Sec. 5. That there is hereby appropriated from the general fund of said Town not otherwise appropriated, a sum not exceeding \$2136.00, for use in furnishing the material to be used in such work.
- Sec. 6. That all of such work shall be under the direct supervision of the street commissioner of the Town of Stayton, who shall keep the Council informed of the progress thereof.
- Sec. 7. That inasmuch as the U. S. Government requires that such work commence immediately to relieve the unemployment situation now prevailing, and inasmuch as it is necessary to commence the same before bad weather sets in, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect immediately following its passage by the Council and approval by the Mayor.
