ORDINANCE NO. 827

AN ORDINANCE AMENDING STAYTON MUNICIPAL CODE CHAPTER 2.28, ("PARK AND RECREATION BOARD"), SECTIONS 2.28.710 ("CREATED"), 2.28.720 ("APPOINTMENT: TERMS OF OFFICE"), AND 2.28.740 ("MEETINGS").

WHEREAS, the City of Stayton Municipal Code (SMC) establishes the Park and Recreation Board (the "Board") for the purpose of advising and providing recommendations to the Stayton City Council;

WHEREAS, the Stayton City Council deems it appropriate to expand the membership of the Board to provide a broader base for decision making;

WHEREAS, the Stayton City Council deems it appropriate that the Board be permitted to choose a day certain for its regular monthly meeting on an annual basis rather than a day certain being designated by the SMC; and,

WHEREAS, it is appropriate that the Stayton City Council and Stayton Public Works Director be notified in a timely manner of the annual designated monthly meeting day and rescind the necessity of the present SMC requirement of actual notices of monthly meetings to members and the Stayton Public Works Director.

NOW THEREFORE, the Stayton City Council does ordain as follows:

SECTION 1: Stayton Municipal Code Section 2.28.710, "CREATED" is hereby amended to read:

For the purpose of maintaining and developing parks and recreations programs, to advise the City Council in such matters, there is created a board of nine (9) people known as the Park and Recreation Board.

SECTION 2: Stayton Municipal Code Section 2.28.720, "APPOINTMENT: TERMS OF OFFICE" is hereby amended to read:

The Park and Recreation Board shall consist of seven (7) members appointed at large, at least five from within the city boundaries, and two (2) high school student members of at least junior level academic standing, one each from Stayton Union High School and Regis High School by the mayor. Members shall be appointed in accordance with the City of Stayton Rules of Council to serve two-year terms (except student members) and may be appointed for any number of terms. Appointments shall be made at the first regularly scheduled City Council meeting each year. High school members shall be voting members serving one-year terms beginning September 1st and ending August 30th each year.

SECTION 3:Stayton Municipal Code Section 2.28.740, "MEETINGS" is hereby amended to read:

- 1. The Park and Recreation Board shall meet at least once a month on a day determined by the Park and Recreation Board with notification of the scheduled meeting date to be provided to the City Council and public by January 31st of each year. Emergency meetings may be called by the chairperson, provided at least twenty-four (24) hours notice is given to the Public Works Director and each member of the Park and Recreation Board.
- 3. All meetings of the Park and Recreation Board shall be open to the public and subject to Oregon's Open Meeting Law.

SECTION 4: Stayton Municipal Code Section 2.28.760 is hereby amended to add:

- 1. Chairperson
 - d. Convey all official recommendations of the Park and Recreation Board to the City Council on or before the next regularly scheduled City Council meeting following Board action.
