

ORDINANCE NO. 828

AN ORDINANCE AMENDING STAYTON CITY ORDINANCE NO. 820 TO EXTEND THE TERM OF THE NON-EXCLUSIVE FRANCHISE OF STAYTON COOPERATIVE TELEPHONE COMPANY FROM APRIL 7, 2001 TO AUGUST 5, 2001; AND, DECLARING AN EMERGENCY.

WHEREAS, the City of Stayton has, through Ordinance No. 617, as amended by Ordinance No. 684, granted a non-exclusive franchise to Stayton Cooperative Telephone Company, an Oregon corporation, to operate a telephone system within the City of Stayton;

WHEREAS, Ordinance No. 816 extended the franchise term to December 7, 2000, and Ordinance No. 820 subsequently extended the franchise term to April 6, 2001, and the extension granted by Ordinance No. 820 has expired;

WHEREAS, the effective date of this proposed Ordinance, and the franchisee's obligations thereunder, should commence April 7, 2001;

WHEREAS, it is appropriate that the City of Stayton and Stayton Cooperative Telephone Company be allotted additional time to consider and negotiate a successor franchise agreement;

WHEREAS, changes in state and federal laws governing the telecommunications industry dictate that the City utilize an orderly process in the development of a franchise agreement that properly reflects such changes;

WHEREAS, Stayton Cooperative Telephone Company has consented in writing to the franchise term extension set forth below;

WHEREAS, upon conclusion of the negotiation for the successor franchise agreement, the new agreement shall, upon approval by the parties, effectively supercede all previous agreements; and

WHEREAS, it is appropriate that an emergency be declared as to the enactment of this Ordinance to ensure continuity so that the franchise remains in full force and effect immediately upon its adoption by the Stayton City Council.

NOW THEREFORE, the Stayton City Council does ordain as follows:

SECTION 1. City of Stayton Ordinance No. 820, as it relates to Ordinance No. 617, Section 10, is amended to read:

Section 10. The rights, privileges and franchises herein granted shall continue and be in force effective from April 7, 2001 to August 5, 2001.

SECTION 2.

All other terms and conditions of Ordinance No. 617, as amended by Ordinance No. 684, shall remain unchanged.

SECTION 3.

Within thirty (30) days after enactment of this ordinance and approval by the Mayor, Stayton Cooperative Telephone Company shall file with the City Administrator for the City of Stayton a written acceptance, attached hereto as Attachment A and by this reference made a part of this ordinance, stating that Stayton Cooperative Telephone Company accepts this amendment to Ordinance No. 820 and agrees to comply with all the terms and conditions of this ordinance.


SECTION 4.
