#### ORDINANCE NO. 678

AN ORDINANCE DECLARING THE ASSESSMENT ON PROPERTY BENEFITED FOR THE COST OF PAVING THE TEN (10) FOOT PARKING STRIP AND IMPROVING DRAINAGE ON THE SOUTH SIDE OF FERN RIDGE ROAD FROM FIRST AVENUE EAST TO THE CITY LIMITS, AND DIRECTING THE FINANCE DIRECTOR TO ENTER A STATEMENT THEREOF IN THE DOCKET OF CITY LIENS.

#### THE CITY OF STAYTON ORDAINS as follows:

SECTION 1: The City of Stayton initiated a project to improve the south side of Fern Ridge Road from First Avenue east to the city limits. A survey of affected property owners indicated support for the improvement, whereupon an engineer's report was prepared and submitted 22 August 1989.

The Common Council of the City of Stayton created the Local Improvement District (LID) by Resolution No. 412 for the improvements on Fern Ridge Road and called for a public hearing. A public hearing was conducted by the Common Council on 22 May 1989, whereby testimony was entered in favor and opposition, the results showing sufficient support to proceed.

The project is complete and the actual cost of the project has been determined.

SECTION 2: It is hereby determined that the proportionate share of the cost of construction of said improvements on each parcel of property adjacent to said improvements and benefited thereby, is the amount set opposite the description of each piece or parcel of land described herein, and that each piece or parcel of land benefited by the construction of said improvement, to the full extent of the amount so set opposite such piece or parcel and that the respective amounts represent the proportional benefits of said improvement to said respective parcels of property, and the Council does hereby declare that each of the parcels of property described herein is hereby assessed the amount set opposite each respective description, for the cost of the construction of said improvements.

SECTION 6: The city administrator of the City of Stayton is hereby directed to enter a statement of these assessments in the docket of city liens, publicize the assessments, and give notice of assessment and installment payment provisions pursuant to Stayton City Ordinance No. 557.
