

AN ORDINANCE REPEALING VARIOUS ORDINANCES

THE CITY OF STAYTON ORDAINS AS FOLLOWS:

Section 1. The Ordinances listed below are hereby repealed in their entirety.

1. ORDINANCE NO. 121: Entitled "AN ORDINANCE TO REGULATE THE PLACING AND ERECTING OF ELECTRIC LIGHT-POLES & WIRES, TELEPHONE POLES AND WIRES, TELEGRAPH POLES AND WIRES, SIGNAL POLES AND WIRES, OR ANY OTHER POLES AND WIRES, OVER, ALONG, OR ACROSS THE STREETS, ALLEYS, ROADWAYS, AND WALKS OF THE TOWN OF STAYTON, OREGON, AND TO PROVIDE FOR THE REPAIR AND MAINTENANCE, AND TO PROVIDE A PENALTY FOR VIOLATIONS OF THIS ORDINANCE." Enacted February 6, 1914.

2. ORIDNANCE NO. 131: Entitled "A BILL FOR AN ORDINANCE TO LICENSE, TAX AND REGULATE CERTAIN CALLINGS AND OCCUPATIONS WITHIN THE TOWN OF STAYTON, OREGON; PRESCRIBING THE CHARACTER OF SAID LICENSES AND THE MANNER OF ISSUING AND COLLECTING THE SAME; FIXING PENALTIES AND RESTRICTIONS IN RELATION THERETO; AND REPEALING ALL OF ORDINANCES NO. 9, 10, 13, 20, 26, 40, 77, 78, 82, 88, 95, 112, AND ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH." Passed & Approved August 1, 1916.

3. ORDINANCE NO. 157: Entitled "A BILL FOR AN ORDINANCE REGULATING PUBLIC DANCE HALLS IN THE TOWN OF STAYTON, PROVIDING A PENALTY AND DECLARING AN EMERGENCY." Passed & Approved October 7, 1919.

4. ORDINANCE NO. 186: Entitled "AN ORDINANCE, PROHIBITING THE POSSESSION, SALE AND MANUFACTURE OF INTOXICATING LIQUOR WITHIN THE TOWN OF STAYTON; DEFINING "INTOXICATING LIQUOR" AS USED IN THIS ORDINANCE; DECLARING WHAT SHALL BE UNNECESSARY TO ALLEGE OR PROVE IN PROSECUTIONS UNDER THIS ORDINANCE; FIXING THE PENALTY FOR VIOLATIONS OF THIS ORDINANCE; AND DECLARING AN EMERGENCY TO EXIST." Passed & Approved December 11, 1922.

5. ORDINANCE NO. 195: Entitled "A BILL FOR AN ORDINANCE TO CREATE AND PROVIDE FOR THE APPOINTMENT OF A MUNICIPAL BOXING COMMISSION; TO PRESCRIBE THE DUTIES OF SUCH COMMISSION, TO REGULATE BOXING COMPETITIONS WITHIN THE TOWN LIMITS OF STAYTON; TO PROVIDE PENALTIES FOR VIOLATION THEREOF AND DECLARING AN EMERGENCY TO EXIST." Passed & Approved February 28, 1927.

6. ORDINANCE NO. 210: Entitled "AN ORDINANCE TO TAX, LICENSE, AND REGULATE THE SALE OF CERTAIN NON-INTOXICATING BEVERAGES, WITHIN THE TOWN OF STAYTON, OREGON, TO DEFINE INTOXICATING AND NON-INTOXICATING BEVERAGES; TO PROVIDE PENALTIES FOR VIOLATION OF THIS ORDINANCE; TO REPEAL OTHER ORDINANCES IN CONFLICT HEREWITH; AND DECLARING AN EMERGENCY." Passed & Approved April 5, 1933.

7. ORDINANCE NO. 228: Entitled "AN ORDINANCE TO AMEND SECTION 6 OF ORDINANCE NO. 226, PASSED BY THE COUNCIL OF THE TOWN OF STAYTON, OREGON ON September 19, 1938, AND APPROVED BY THE MAYOR ON September 19, 1938; AND DECLARING AN EMERGENCY. Passed & Approved December 22, 1938.
8. ORDINANCE NO. 231: Title and enactment date unknown.
9. ORDINANCE NO. 232-B: Entitled "AN ORDINANCE PROVIDING FOR THE REGISTRATION AND OPERATION OF BICYCLES WITHIN THE TOWN OF STAYTON, OREGON; PROVIDING A PENALTY, REPEALING CONFLICTING ORDINANCES; REPEALING ORDINANCE NO. 232, AND DECLARING AN EMERGENCY." Undated but enacted in 1939.
10. ORDINANCE NO. 240: Title and enactment date unknown.
11. ORDINANCE NO. 246: Entitled "AN ORDINANCE PROVIDING FOR THE FILING OF PETITIONS OF CANDIDATES FOR NOMINATION TO OFFICE; FIXING THE TIME OF HOLDING PRIMARY ELECTIONS; AND PROVIDING THE FORM OF POLL BOOKS AND OFFICIAL BALLOTS." Passed and Approved April 20, 1942.
12. ORDINANCE NO. 253: Entitled "AN ORDINANCE TO PROHIBIT SOLICITORS AND PEDDLERS FROM GOING IN AND UPON PRIVATE RESIDENCES, AND PROVIDING A PENALTY FOR VIOLATION THEREOF." Passed & Approved April 20, 1942.
13. ORDINANCE NO. 254: Entitled "AN ORDINANCE ESTABLISHING A BOARD OF HEALTH, DEFINING ITS POWERS AND DUTIES, ESTABLISHING THE OFFICE OF HEALTH OFFICER, DEFINING HIS POWERS AND DUTIES, ADOPTING BY REFERENCE STATE HEALTH LAWS AND HEALTH REGULATIONS, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF." Passed & Approved April 20, 1942.
14. ORDINANCE NO. 259: Entitled "AN ORDINANCE PROVIDING FOR THE CONSTRUCTION OF SEPTIC TANKS." Passed & Approved April 20, 1942.
15. ORDINANCE NO. 264: Entitled "AN ORDINANCE DIVIDING THE TOWN OF STAYTON, OREGON, INTO ZONES, PRESCRIBING THE USES TO WHICH PROPERTY IN SUCH ZONES MAYBE PUT OR USED, AND PROVIDING PENALTIES FOR VIOLATION THEREOF." Passed & Approved October 8, 1945.
16. ORDINANCE NO. 266: Entitled "A BILL FOR AN ORDINANCE PROVIDING FOR THE APPOINTMENT OF A DEPUTY RECORDER AND OTHER ASSISTANTS AND PROVIDING FOR THE COMMON COUNCIL OF THE TOWN OF STAYTON TO FIX AND ALLOW THE SALARIES OF CERTAIN OFFICERS; REPEALING ORDINANCES 245 and 261 AND DECLARING AN EMERGENCY TO EXIST." Passed & Approved August 2, 1948.
17. ORDINANCE NO. 291: Entitled "AN ORDINANCE PRESCRIBING SET BACK REGULATIONS FROM PROPERTY LINES AND OTHER BUILDINGS FOR DWELLINGS; AND DECLARING AN EMERGENCY. Passed & Approved May 7, 1956.
18. ORDINANCE NO. 293: Entitled "AN ORDINANCE ESTABLISHING A CITY PLANNING COMMISSION AND PRESCRIBING ITS POWERS AND DUTIES." Passed & Approved June 4, 1956.

19. ORDINANCE NO. 297: Entitled "AN ORDINANCE PERMITTING THE CITY COUNCIL TO CONTROL AND REGULATE THE DISTRIBUTION OF ANY COMMODITY BY CONDUIT OR PIPELINE WITHIN THE CORPORATE LIMITS OF THE TOWN OF STAYTON. Passed & Approved November 4, 1957.

20. ORDINANCE NO. 310: Entitled "AN ORDINANCE CREATING A SINKING FUND TO PLAN, PROMOTE, CONSTRUCT, FINANCE, AND OPERATE A SEWERAGE DISPOSAL SYSTEM AND RETIRE EXISTING SEWERAGE INDEBTEDNESS AND DECLARING AN EMERGENCY," Passed & Approved January 8, 1962.

21. ORDINANCE NO. 352: Entitled "AN ORDINANCE PROVIDING FOR THE AMENDMENT OF ORDINANCE NO. 264 RELATING TO DIVISION OF THE CITY OF STAYTON, OREGON, INTO ZONES, PRESCRIBING THE USES TO WHICH PROPERTY IN SUCH ZONES MAY BE PUT OR USED, AND PROVIDING PENALTIES FOR VIOLATION THEREOF." Passed & Approved April 21, 1966.

22. ORDINANCE NO. 390: Entitled "AN ORDINANCE TO AMEND SECTIONS 2, 4, and 6 OF ORDINANCE NO. 293 RELATING TO A CITY PLANNING COMMISSION AND PRESCRIBING ITS POWERS AND DUTIES; AND DECLARING AN EMERGENCY." Passed & Approved December 15, 1969.


23. ORDINANCE NO. 396: Entitled "AN ORDINANCE AMENDING ORDINANCE NO. 326 OF THE CITY OF STAYTON TO PROVIDE A SANITARY SEWER BILL DEPOSIT." Passed & Approved August 3, 1970.

24. ORDINANCE NO. 407: Entitled "AN ORDINANCE AMENDING SECTION 11 and 34 OF ORDINANCE NO. 337 OF THE CITY OF STAYTON, ENACTED JUNE 29, 1964, AND DECLARING AN EMERGENCY." Passed & Approved June 7, 1971.


Section 2. The repeal of the ordinances listed herein shall not be construed as reinstating any ordinance, section, or clause that may have been repealed or amended by such ordinances.
