## ORDINANCE NO. 9191.

For an Ordinance to regulate Public Billiard and Pool rooms, and to Prohibit Owners, keepers or other persons in charge of such rooms from allowing Minors therein, and to fix the hour of closing the same, and providing a penalty for violations of this Ordinance, and to repeal all of Ordinance No 164, passes by the Council on July the 5th 1921, And declaring an emergency to exist.

THE TOWN OF STAYTON DO ORDAIN AS FOLLOWS;

It shall be unlawfull for any owner, keeper or other Section 1, person in charge of any Public Billiard or Pool room within the Town of Stayton, Oregon, to permit or allow any Minor or Minors to be or remain in any such Billiard or Pool room at any time; Provided that Minors may enter a seperate appartment or room in such Building for to be or the purpose of purchasing such articles of merchandise as are kept there for sale to the Public, but must not be allowed to loiter around such room after making their purchases but shall immediately depart therefrom.

Section 2, It shall be unlawfull for any Minor to go into or remain in any Public Billiard or Pool room within the Town of Stayton, except as provided in Section one of this ordinance, and he or they must depart immediately after complecting their purchases.

Section 3, It shall be unlawfull for any owner, keeper or other person in charge of any public Billiard or Pool soom within the Town of Stayton, Oregon, to keep the same open for traffic from and after the hour of Eleven Oclock in the evening, untill Six Oclock of the following morning; ( Provided that on Saturday evenings such Billiard or Pool room may be kept open for traffic untill Twelve Oclock in the evening at which hour all such rooms shall be closed as set forth insection 3 of this ordinance.

Section 4, Any person violating any of the provisions of this ordinance shall upon conviction thereof in the Recorders Court of the Town of Stayton, be punished by a fine of not less than Ten nor more than Fifty Dollars, or by imprisonment in the Town Jail not exceeding 20 days; or by both such fine and imprisonment at the discretion of the Recorder.

That all of ordinance No 164 passed by the Council of the Section 5, the Town of Stayton, and approved by the Mayor on the 5th day of July 1921, be and the same is hereby repealed.

Section 6. Whereas there is no adaquate ordinance now in force to regulate Public Billiard or Pool rooms in the Town of Stayton, it is the judgement of this Council that an emergency exists, and that mmmmum for theimmediate preservation of the peace health and safety of the Town of Stayton it is necessary that this ordinance shall take effect and be in force upon its passage by the Council and approval by the Mayor.
