## ORDINANCE NO. 507

AN ORDINANCE ADOPTING A CODIFICATION OF THE ORDINANCES OF THE CITY OF STAYTON ENTITLED "STAYTON CODE", AND REPEALING CERTAIN ORDINANCES OF THE CITY.

Be it ordained by the City of Stayton:

Section 1. Adoption of the Stayton Code. The City of Stayton hereby adopts by reference that certain code of ordinance provisions of the City entitled "Stayton Code" that the Council received on October 16,1978, and ordered placed on file for public inspection in the office of the Administrator, and that has since continuously been so on file and available for public inspection during regular office hours, as fully as if this ordinance set forth in full the entire contents of the Code.

Section 2. Repeal of Existing General Ordinances. The following Stayton general ordinances are hereby appealed:

- Section 3. Saving Cause. This ordinance shall not affect:
- 1. Any offense or act committed or done, any penalty or forfeiture incurred, or any contract or right established or accruing before this ordinance is enacted;
- 2. Any ordinance or resolution promising or guaranteeing the payment of money by the City or authorizing any contract or the issuance of any obligation assumed by the City;
  - 3. The legal status of any nonconforming use;
  - 4. Any tax levy;
- 5. Any right or franchise conferred by ordinance or resolution on any person or corporation;
- 6. The term of office of members of the Planning Commission and members of all other city offices, official positions, boards, or commissions created under an ordinance repealed by this ordinance; these officials shall continue to hold office for the period of time specified in the repealed ordinance;
  - 7. Any ordinance relating to the boundaries of the City;
  - 8. Any ordinance annexing territory to the City;

- 9. Any ordinance naming, opening, accepting, or vacating a street or alley;
- 10. Any ordinance relating to a street, sidewalk, alley, sewer, or other public improvement or an assessment therefor;
- 11. Any prosecution, suit, or proceeding pending at the time this ordinance is enacted; or
- 12. Any judgment rendered prior to the time this ordinance is enacted.
- <u>Section 4</u>. This ordinance being necessary for the preservation of public safety and welfare, this ordinance shall become in full effect thirty (30) days from the date of approval by the Common Council of the City of Stayton.

## EXHIBIT "A"

## ORDINANCES TO BE REPEALED BY ORDINANCE ADOPTING CODE

225. "An Ordinance to regulate the use of advertising matter and devices upon, over or across sidewalks, street, alleys, or other public property within the Town of Stayton; to provide penalties for the violation of this ordinance; to repeal conflicting ordinances".

PASSED AND APPROVED 6 DECEMBER 1937

227. "An Ordinance to provide for a fire committee; to provide for and regulate a volunteer fire department within the Town of Stayton; to regulate the use of fire fighting equipment; to provide penalties for violations; to repeal conflicting ordinances; and repealing Ordinance No. 227; and to declare an emergency".

229. "An Ordinance to provide for the numbering of buildings within the Town of Stayton; to provide for penalties for violations; and declaring an emergency".

230. "An Ordinance to amend Section 6 of Ordinance No. 229, of the Town of Stayton, providing for the numbering of structures within said Town; and declaring an emergency".

PASSED AND APPROVED 10 JULY, 1939

242. "An Ordinance providing for the manner of exercising the initiative and referendum powers reserved to the legal voters of municipalities by Section la of Article IV of the Constitution of the State of Oregon, and to provide the manner whereby said legal voters may enact and amend their municipal charter under the powers reserved to them by Section 2 of Article XI of the Constitution of the State of Oregon".

243. "An Ordinance fixing the time and place for holding meetings of the Common Council and prescribing rules and regulations for its proceedings".

285. "An Ordinance defining, regulating, and licensing solicitors and canvassers and providing penalties for the violation thereof."

294. "An Ordinance to regulate the use and obstruction of sidewalks, alleys and providing penalties for the violation thereof."

PASSED AND APPROVED 1 APRIL, 1957

296. "An Ordinance defining nuisance, prohibiting their creation or maintenance and providing a penalty for violation thereof."

PASSED AND APPROVED 4 NOVEMBER, 1957

300. "An Ordinance providing for the general plan of constructing sidewalks and curbs in the Town of Stayton; specifying the kind of sidewalks and curbs to be built; the wiedth and location thereof, the material to be used and the specifications for the construction thereof; providing for the construction, repair, and cleaning of sidewalks in the Town of Stayton at the

expense of the owners of property adjacent to and abutting upon such sidwalks; providing for the method of charging the cost thereof against the owner of the premises; providing the method of notice to said owners or occupants; providing for the securing of a permit to construct sidewalks; providing for the construction of sidewalks and curbs upon official grades; fixing the dimension of curbs; establishing curb lines on certain width streets; prescribing penalties for violation of the terms of this ordinance; and repealing Ordinance Nos. 128 and 135."

"An Ordinance to regulate the keeping and running at large of dogs; to prohibit the owner or custodian of any dog from allowing the dog to run loose or be at large upon any street or in any public place; to authorize the impounding, selling, or killing of dogs found loose and at large in violation of this Ordinance; to authorize constructing for the keeping and disposing of dogs taken into custody pursuant to this ordinance and for the giving of notice to the owners or custodians of such dogs concerning the impounding and disposing thereof; providing for the enforcement of this ordinance by the Chief of Police; providing fines and penalties for violations of this ordinance; repealing ordinances Numbered 262 and 263; and declaring an emergency."

384. "An Ordinance providing for the construction, improvement and acceptance of streets within the City of Stayton; repealing Ordinance Number 292; and declaring an emergency."
