A RESOLUTION INITIATING THE VACATION OF VARIOUS ALLEYS IN THE CITY OF STAYTON

WHEREAS, an inventory of alleys within the City of Stayton has revealed a number of alleys that are not used for vehicular traffic, City-owned utility facilities or privately owned utility facilities:

WHEREAS, it is within the City of Stayton's authority under ORS 271.130 to initiate the vacation of streets and alleys; and

WHEREAS, the Stayton City Council has determined that it may be in the public interest to vacate alleys that are not used by the public, the City's utilities or private utilities;

NOW, THEREFORE,

BE IT RESOLVED that the Stayton City Council does initiate the vacation of the following alleys:

- Alley between N First Ave and N Second Ave and running from E Pine St E to Fir St;
- Alley between N First Ave and N Second Ave and running from E Fir St to E Cedar St;
- Alley between N Second Ave and N Third Ave and running from E Fir St to E Cedar St;
- Alley between N Third Ave and N Fourth Ave and running from E Burnett St to E Virginia
 St:
- Alley between N Third Ave and N Fourth Ave and running north from E Robidoux St;
- Alley between N Fourth Ave and N Fifth Ave and running south from E Marion St;
- Alley between N Fourth Ave and N Fifth Ave and running from E Robidoux St to E Hollister St;
- Alley between N Fourth Ave and N Fifth Ave and running from E Jefferson St to E Santiam St;
- Alley between N Fifth Ave and N Sixth Ave and running from E Burnett St to E Virginia St;
- Alley between N Sixth Ave and N Seventh Ave and running from E Burnett St to E Virginia
 St
- Alley between N Sixth Ave and N Seventh Ave and running from E Virginia St to E Washington St;
- Alley between N Sixth Ave and N Seventh Ave and running from E Washington St to E
 Jefferson St;
- Alley between N Alder Ave and N First Ave and running north from E High St;
- Alley between N Alder Ave and N Cherry Ave and running north from E High St;
- Alley between N Douglas Ave and N Evergreen Ave and running south from E Water St;

BE IT FURTHER RESOLVED that notice of the potential vacation of these alleys be provided to the owners of all property abutting the listed alleys and any other owners of affected property in accordance with ORS 271.080(2);

BE IT FURTHER RESOLVED that notice of the potential vacation of these alleys be provided to the franchise utilities that operate within the City of Stayton;

BE IT FURTHER RESOLVED that the Stayton Planning Commission is requested to hold a public hearing, with notice to the public as required by ORS 271.110, and following the public hearing make a recommendation to the Stayton City Council; and

BE IT FURTHER RESOLVED that following the Planning Commission's public hearing the Stayton City Council shall hold a public hearing, with notice to the public as required by ORS 271.110, regarding the potential vacation of the listed alleys.

This Resolution shall become effective upon its adoption by the Stayton City Council. ADOPTED BY THE STAYTON CITY COUNCIL this 20th day of July, 2015.
