## RESOLUTION CREATING A LAND USE APPLICATION DEPOSIT SCHEDULE

WHEREAS, the City Council for the City of Stayton has adopted Ordinance No. 794, "An Ordinance Amending Stayton Municipal Code Title 17, "Land Use and Development", Chapter 17.12 "Development Approval Procedure", Section 17.12.330 "Application Procedure", and Section 17.12.340 "Multiple Applications"; and

WHEREAS, Ordinance No. 794 requires a deposit to be paid anticipating the city's costs for processing land use applications; and

WHEREAS, Ordinance No. 794 requires the deposit be made by land use applicants at the initiation of the application process; and

WHEREAS, it is the practice of the City Council that fees, charges and/or deposits be set in resolution form; the expense incurred by the city staff is determined by the criteria set by the City Administrator;

NOW THEREFORE, be it resolved by the Stayton City Council that the City of Stayton hereby adopts the following deposit schedule:

DEPOSIT SCHEDULE: Specific applications shall be subject to the following minimum deposits, to be submitted with the application and not refunded once the application is accepted by the city planner. Before final approval and signature, the actual costs of processing the application must be satisfied.
