A RESOLUTION ASSIGNING WATER RATES: METERED SERVICE FOR WATER SERVICE PROVIDED BY THE CITY OF STAYTON.

- WHEREAS, The Stayton City Council for the City of Stayton has adopted Ordinance No. 805, "Repealing SMC Title 13.16.440"; and,
- WHEREAS, Ordinance No. 805 (SMC Title 13.16.440) requires rates to be established for water service; and,

WHEREAS, such rates are to be set in resolution form;

NOW THEREFORE, be it resolved by the Stayton City Council that the City of Stayton hereby adopts water rates as follows:

SECTION 1. WATER RATES, METERED SERVICE

Water rates shall be established and set by the Council as follows:

- Base Rate: the base rate is \$4.75 per month. a.
- b. Meter equivalent charge per meter per month. Compound meters shall be charged only on the largest meter in the compound at each service:
