RESOLUTION NO. 662

A RESOLUTION REPEALING RESOLUTION NO. 656 RELATING TO RATES FOR SOLID WASTE MANAGEMENT IN THE CITY OF STAYTON.

WHEREAS, the Stayton City Council deems that Stayton Municipal Code Chapter 4.08.020(1)(b) permits the establishment of rates for the collection of solid waste;

WHEREAS, the Stayton City Council determined it to be both appropriate and timely to consider additional solid waste service including expanded recycling, an automated solid waste removal system, and yard debris service for all customers;

WHEREAS, the Stayton City Council conducted a Public Hearing on April 17, 2000 to receive public testimony regarding the proposed new services and adjustments in rates to reflect the addition of such services; and

WHEREAS, the Stayton City Council determined that the rate schedules addressed herein are fair, reasonable, and competitive.

NOW THEREFORE,

BE IT RESOLVED that:

Rates for Monthly Service, effective July 1, 2000, shall be as follows:

Residential Service*

One 20 gallon roll cart	\$14.00
One 32 gallon roll cart	\$17.00
One 60 gallon roll cart	\$23.50
One 90 gallon roll cart	\$26.50

^{*}Rate includes a 60 gallon roll cart for yard debris.

Multi-Family Apartments and Mobil Home Parks*

This rate applies to multi-family apartments and mobile home parks when there are five or more adjoining units and a single billing is used:

One 20 gallon roll cart	\$13.00
One 32 gallon roll cart	\$16.00
One 60 gallon roll cart	\$22.50
One 90 gallon roll cart	\$25.50

^{*} Rate includes a 60 gallon roll cart for yard debris.
