A RESOLTUION ADOPTING A PROPOSED AMENDMENT TO THE COMPREHENSIVE PLAN AND FORWARDING THE MATTER TO MARION COUNTY FOR APPROVAL

WHEREAS, the City of Stayton received a petition for annexation to the City Limits of certain property described in Attachment A; and

WHEREAS, the City of Stayton initiated an annexation petition on other certain properties described in Attachment B; and

WHEREAS, finding the petitions to be in order, set and held a duly noticed public hearing to consider the propriety of the annexations; and

WHEREAS, upon such hearing, the Planning Commission and City Council having determined that the public interest would be served by including the subject properties within the City, and have taken all the necessary steps to include the subject properties by Ordinance; and

It appearing to the Council that all City initiated amendments to the Comprehensive Plan shall, by agreement, be forwarded to the County for County review and consideration:

NOW THEREFORE,

BE IT RESOLVED

That the proposed amendment to the Comprehensive Plan be adopted and all evidence, findings of fact, and conclusions of law regarding the amendment shall be forwarded to Marion County for its review and consideration. Upon concurrence by the County, the City shall amend its Comprehensive Plan Map to include within the City that property described in the petitions.

ATTACHMENT A

Beginning at an iron pipe which point is the center of Section 9, Township 9 South, Range 1 West, Willamette Meridian; thence West 1760 feet (106 2/3 rods); thence South 00 45 West 2095.6 feet to a point which is the Northwest corner of this tract and the true point of beginning; thence 313.05 feet East; thence South 417.4 feet to the North line of the present County Road; thence in a Southwesterly direction 314.9 feet along the North line of said County Road to the West line of said tract; thence North from this point, 451.3 feet to said Northwest corner of this tract and the true point of beginning. Except that portion of the above described tract of land lying within the boundaries of public roads and highways.

ATTACHMENT B

Beginning on the legal subdivision line running North and South through the center of Section 9, Township 9 South, Range 1 West, of the Willamette Meridian, Marion County, Oregon, at a point which is 168.62 feet North 0° 22' East from the quarter corner on the South line of said Section; thence West 937.36 feet; thence North 9.17 feet to a point on the South line of Market Road No. 32 (being West Washington Street in the City of Stayton); thence Northeasterly along said South line on a 848.51 foot radius curve left, (the chord of which bears North 62° 19' East 127.98 feet) an arc distance of 128 feet to the point of tangent; thence continuing along said South line of Market Road No. 32 North 58° 3' East 780.38 feet to the South line of Ida Street in the City of Stayton; thence East along said South line of Ida St. 108.48 feet more or less to a point on the said North South subdivision line; thence South 0° 22' West 481.95 feet to the place of beginning.
