RESOLUTION NO. 258

WHEREAS, it appears that there has been filed with the City of Stayton, Oregon, pursuant to ORS 222.170, a petition representing more than one-half of the land owners of certain territory contiguous to the City of Stayton, described in Section 1 hereof, said territory being in the Vicinity of Westown Drive, North of Shaff Road, which said petitioners also own more than one-half of said land in the contiguous territory and of real property therein, representing more than one-half of the assessed value of all said property, which said petitioners desire inclusion of such territory within the corporate limits of the City of Stayton and;

WHEREAS, the subject property is within an adoped urban growth boundary, contiguous to the existing corporate City Limits with a land use designation of Low Density Residential;

NOW, THEREFORE BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF STAYTON, OREGON.

Section 1. That pursuant to Chapter 199, Oregon Revised Statues, the Common Council hereby initiates proceeding for the annexation to the City of Stayton, Oregon, of the territory lying contiguous to the present City Limits and more particularly described as follows:

Beginning on South boundary of the Henry Foster Donation Land Claim No. 45 in Township 9 South, Range 1 West, 20.00 chains Westerly from the Southeast corner of said Claim, said beginning point being the Southwest corner of L. S. Lambert's land deeded to him by J. I. Crabtree, said deed being recorded in Volume t1, page 453; thence Westerly on said South boundary of said Donation Land Claim 21.48 chains to Southeast corner of a 20 acre tract of land formerly owned by Mary J. Cartwright, thence North 00 15" West on line of said 20 acre tract 19.00 chains; thence Easterly, parallel with the South boundary of said Donation Land Claim, 21.68 chains, to L. S. Lambert's West line; thence South 00 45' East 19.00 chains along the L. S. Lambert's West line to the beginning and containing 41 acres of land.

And;

Beginning at an iron pipe which is 1349.70 feet South 89° 45' West and 1254.00 feet North 00° 17' West from the Southeast corner of the Henry Foster Donation Land Claim in Township 9 South, Range 1 West of the Willamette Meridian, Marion County, Oregon; and running thence South 89° 45' West 1423.39 feet to an iron pipe in the West line of that certain tract of land conveyed to William Rauscher by deed recorded in Volume 506, Page 619, Marion County Deed Records; thence North 0° 9' 30" West, along said West line, 596.90 feet to an iron pipe, which iron pipe is 602.13 feet South 00° 09' 30" East from the Northwest corner of said Rauscher Tract; thence North 89° 45' East, 1422.19 feet to an iron pipe; thence South 00° 17' East 596.90 feet to the point of beginning and containing 19.50 acres of land.
