RESOLUTION NO. 23

RESOLUTION OF THE COMMON COUNCIL OF THE TOWN OF STAYTON, MARION COUNTY, OREGON.

BE IT REMEMBERED THAT at a meeting of the common council of the town of Stayton, Marion County, Oregon held this 2nd day of February, 1953, the following action was taken:

In the matter of the vacation of a sixteen foot alkey running north and south through Block 8, U. Whitney's Addition, Stayton, Marion County, Oregon

RESOLVED:

That whereas, it has come to the attention of the common council that the alley as it exists in Block 8, U. Whitney's Addition to the town of Stayton, Marion County, Oregon, has never been improved or opened, and

Whereas, the home now owned by Hattie Paris and previously constructed by a prior owner is actually constructed over and across the north entrance of said alley, and that the south entrance of said alley dead ends on the Salem Water Ditch, and therefore, said alley will never be opened or improved for use by the general public, and

Whereas, that said alley has never been opened or improved or used by the general travelling public;

FE IT RESOLVED by the common council of the Town of Stayton, Marion County, Oregon:

Section 1. That a public hearing is hereby called to be held on the 11th day of March, 1953 at the hour of 8:00 p.m. on the question as to whether or not the following described alley in Block 8 U. Whitney's Addition to the town of Stayton, Marion County, Oregon should be vacated, to-wit:

A sixteen (16) foot alley running North and South and bordered by the South line of Marion Street on the North and the Salem Water Ditch on the South, being a sixteen foot alley located in Block 8, U. Whitney's Addition to the Town of Stayton, Marion County, Oregon

Section 2. Said public hearing is to commence at 8:00 o'clock p.m. on the 11th day of March, 1953 and said hearing is for the purpose of considering and hearing objections to the proposition of whether or not the above described sixteen foot alley running North and South and bordered by the South line of Marion Street on the North and the Salem Water Ditch on the South, and being located in Block 8, U. Whitney's Addition to the Town of Stayton, Marion County, Oregon, should be vacated.

Section 3. The City Recorder is hereby directed to publish notices of said hearing once each week for four consecutive weeks and said notice of hearing on vacation is to be published in the Stayton Mail; said notice to designate the date, time and place of said hearing and the purpose of said hearing as to the proposition of the vacation of the hereinbefore described sixteen foot alley. The City Recorder also is hereby directed to cause to be posted at the North entrance of said alley and on the Salem Water Ditch at the South of said proposed vacation a copy of said notice which should be headed "NOTICE OF STREET VACATION".
