

## ORDINANCE NO. 941

AN ORDINANCE AMENDING THE STAYTON MUNICIPAL CODE TO REFLECT THE OREGON LEGISLATIVE AND AGENCY ADMINISTRATIVE CHANGES (from 2010 to 2011); AND, DECLARING AN EMERGENCY

WHEREAS, this Ordinance shall be known as the:

### **“2011 Oregon Revised Statutes and Administrative Rules Incorporation Ordinance.”**

WHEREAS, the purpose of this Ordinance is to amend the Stayton Municipal Code (“SMC”) by adopting the legislative and administrative rule changes, including amendments, additions, and repeals, made by the Oregon Legislature and the applicable Oregon Agencies, to the Oregon Revised Statutes (“ORS”) and the Oregon Administrative Rules (“OAR”; “Rules”) that are referenced in the SMC during the 2010 Special Legislative Session and 2011 Regular Legislative Session; and,

WHEREAS, in the interest of facilitating consistency between references to the ORS and the OAR in the SMC, and amendments, additions, and repeals to those ORS and OAR references by Oregon Laws, it is the policy and intent of the City of Stayton to adopt the amendments to, additions to, and repeals of those ORS and OAR references, following consideration thereof, as provided in the Oregon Laws; and,

WHEREAS, because the legislative and agency changes reflected in this Ordinance date back to 2010, and in order to accomplish this task as soon as possible, it is appropriate that an emergency be declared in the enactment of this Ordinance so that it is immediately in full force and effect once adopted by the Stayton City Council and signed by the Mayor.

NOW, THEREFORE, the City of Stayton ordains:

#### **DIVISION 1. GENERAL PROVISIONS**

**Section 1. Short Title.** This Ordinance shall be known as the “2011 Oregon Revised Statutes and Administrative Rules Incorporation Ordinance,” and cited herein as “Ordinance.”

#### **Section 2. Attachments.**

**2.1** Attached marked Exhibit A is a table showing all references to extramunicipal law found in the SMC in order of appearance with a column that shows which of those references were changed by state legislative action in 2010 and 2011.

2.2 Attached marked Exhibit B is a printout of the applicable 2010 and 2011 Oregon Laws that affect state law references in the SMC. The Oregon Laws included here are arranged by date and by chronologic chapter and section numbers.

**Section 3. Adoption.** The SMC is amended to adopt and incorporate all above-referenced amendments to Oregon Laws and Rules from 2010 through 2011.

**DIVISION 2. EMERGENCY CLAUSE**

Upon adoption by the Stayton City Council and the Mayor's signing, this Ordinance shall become immediately effective.
