

ORDINANCE NO. 445

AN ORDINANCE CALLING FOR A SPECIAL ELECTION ON ANNEXATION OF THE CITY TO THE STAYTON RURAL FIRE PROTECTION DISTRICT.

WHEREAS, the City of Stayton, Marion County, Oregon, does have an organized fire department; and

WHEREAS, the City of Stayton is adjacent to the boundaries of the Stayton Rural Fire Protection District; and

WHEREAS, the Common Council of the City of Stayton believes it to be in the best interest of the City of Stayton to have one fire department for the City of Stayton and the surrounding area; now, therefore,

THE CITY OF STAYTON ORDAINS AS FOLLOWS:

Section 1. The City of Stayton by its Common Council does elect to be annexed to and become part of the Stayton Rural Fire Protection District for the purpose of furnishing fire protection to the inhabitants of the City of Stayton, subject to approval by the legal voters of the City.

Section 2. A special election is hereby called to be held on the 25 day of MARCH, 1975, at which the following question shall be submitted to the voters:

"Shall the City of Stayton be annexed to and become a part of the Stayton Rural Fire Protection District for the purpose of furnishing fire protection to the inhabitants of the City of Stayton.

That for the above proposed annexation, the ballot shall be substantially as follows:

BALLOT

CITY OF STAYTON

Marion County, Oregon

Special Election held on MARCH 25, 1975.

Submitted to the electors within the City of Stayton by the Common Council of the City of Stayton.

MARK A CROSS (X) OR CHECK ( ) INSIDE THE VOTING SQUARE AFTER THE WORD "YES" OR AFTER THE WORD "NO". If you wrongfully mark, tear, erase, or deface the ballot, return it and obtain another from the election officers.

FIRE DEPARTMENT ANNEXATION

1. Shall the City of Stayton be annexed to and become a part of the Stayton Rural Fire Protection District for the purpose of furnishing fire protection to the inhabitants of the City of Stayton?

( ) Yes, I vote for the annexation

( ) No, I vote against the annexation

Section 3. That the Recorder be, and he is hereby, instructed to give notice of such election in the manner provided by law and the matter shall be submitted at said election as required by the Charter and Ordinance of said City.

Section 4. That for the purpose of this election there shall be one precinct which shall be as follows:

City Precinct number 1, shall consist of all the area in the City of Stayton and the voting place shall be the City Hall, 362 N. Third Avenue, Stayton, Oregon.

The hours of the election shall be 8:00 o'clock a.m. Pacific Daylight Savings time to 8:00 o'clock p.m. Pacific Daylight Savings time.

Section 5. That in the event the vote shall be canvassed and found to be favorable for said election to annex, that a certificate of said election shall be caused to be submitted to the County Board and the Stayton Rural Fire Protection District.

Section 6. That in the event the said vote in said city is favorable and the vote in the rural fire district is also favorable, that the Common Council of the City of Stayton shall proceed to do the necessary steps to effectuate this annexation.

Section 7. This ordinance being necessary for the immediate preservation of the public safety, an emergency is hereby declared and this ordinance shall be in full force and effect from and after its passage.

Adopted by the Common Council and approved by the Mayor of the City of Stayton this 6 day of March 1975.
