

A BILL FOR AN ORDINANCE NO 188.
To amend Ordinance NO, 130, Entitled 'an Ordinance to prevent

domestic animals from running at large within the Town of Stayton, and to provide for the taking up and impounding the same; and to repeal Ordinances NO, 4, 5, 30, 52, 73, 74, and 81, and all Ordinances or parts of ordinances in conflict herewith', and to declare an emergency to exist.

THE COUNCIL OF THE TOWN OF STAYTON DO ORDAIN AS FOLLOWS:

Section, 1, That sections 1, and 7, of Ordinance No, 130, be and the same is hereby amended so as to read as follows, to-wit;

Section, 1, No Horses, Mules, Cattle, Sheep, Goats or Swine shall be allowed to run at large or be herded in any Street or Alley, or any Public place within the Town of Stayton, or be kept, put or grazed upon any Lawn, or private premises without the consent of the owner or occupent of the premises. And whenever such animals are staked on any lawn or premises, they shall not be allowed to go upon any walk, street or alley, and must be so securely staked or fastened that they can not get loose.

Provided, that when domestic animals are being driven on the streets or alleys of the town, such animals so driven shall be kept off Lawns and Gardens, and out side of the Walks or curbs, and the owner of such live stock will be liable for all damage to lawns or gardens.

Provided further, that when any live stock shall be driven on the streets or alleys within the town and carefully and properly attended and kept off lawns and gardens, they shall not be considered as running at large within the meaning of this Ordinance.

Section 7, The Marshal shall be entitled to a fee of \$ 2.50, per head for taking up and impounding any Horse, Mule, or Cattle, and \$ 1.50 per head for taking up and impounding any Sheep, Goats or Swine, to be paid by the owner or driver to gether with a reasonable sum for keeping and careing for the same, which sum must be paid to the Marshal before such animal or animals will be released; And in case of sale of any animal or animals taken up by the Marshal, he shall be entitled to and recieve 10 per cent of the proceeds of such sale when the amount thereof does not exceed the sum of \$ 25.00 and 5 per cent of any sum in excess of \$ 25.00.

Section 8, In as much as there is no sufficient Ordinance in force to prevent live stock from running at large within the Town of Stayton, it is the judgement of this Council that an emergency exists, and that this Ordinance is necessary for the immediate preservation of the peace, health and safety of the people of the Town, and that this Ordinance shall take effect and be in full force and effect immediately upon its passage by the Council, and approval by the Mayor.
