

RESOLUTION NO. 821

A RESOLUTION ASSIGNING WATER RATES: METERED SERVICE FOR WATER SERVICE PROVIDED BY THE CITY OF STAYTON.

WHEREAS, the Stayton Municipal Code (SMC) Title 13.16.440 prescribes the establishment of rates for water service;

WHEREAS, such rates are to be set in resolution form by the Stayton City Council;

WHEREAS, the adopted water master plan recommends a 10% water rate increase July 1, 2008; and,

WHEREAS, the Stayton City Council deems it appropriate and timely that water rates more accurately reflect and support the fiscal needs of the City's water system and service in accordance with the Water Master Plan.

NOW THEREFORE, BE IT RESOLVED that:

Water rates are hereby adopted July 1, 2008 as follows:

SECTION 1. WATER RATES, METERED SERVICE

Water rates shall be established and set by the Council as follows:

- a. Base Rate: the base rate shall be adopted as follows:

- b. Meter equivalent charge per meter per month. Compound meters shall be charged only on the largest meter in the compound at each service. The monthly rates for metered equivalent charge per month shall be adopted as follows:

- c. Fire Line Schedule: Fire line charges shall be for the maintenance of the line only; not for water flow activity. The monthly rates for fires lines shall be adopted as follows:

- d. Fire Standby Charge: A fire standby charge shall be levied on each occupancy served by City water. In occupancies that are served by more than one water service, the charge shall be levied only on one service. The monthly rates for fire standby shall be adopted as follows:

- e. Commodity Charge: A commodity charge per 1000 gallons water usage shall be levied as follows:
