

RESOLUTION NO. 25

RESOLUTION OF THE COMMON COUNCIL OF THE TOWN OF STAYTON,  
OREGON.

BE IT REMEMBERED, That at a meeting of the Common Council of the Town of Stayton, Oregon held this 2nd day of March, 1953, the following action was taken.

IN THE MATTER OF THE ANNEXATION OF REAL PROPERTY)  
TO THE TOWN OF STAYTON, MARION COUNTY, OREGON. ) RESOLVED

That Whereas, a petition has been filed with the required number of signatures for annexation of real property to the Town of Stayton, Oregon, and whereas said petitioners and signers of said petition have asked to be annexed to the Incorporate Town of Stayton, Oregon, and

Whereas, the City Recorder of the Town of Stayton has examined said petition herein described and found that the signers of said petition constitute all and the only owners in the area requested to be annexed, and

Whereas the Common Council of the Town of Stayton has decided, by motion and order, to call for a public hearing on the question of whether or not the Common Council of the Town of Stayton should annex the herein described real property.

Therefore:

Be it resolved by the Common Council of the Town of Stayton, Oregon.

Section 1. That a Public hearing is hereby called to be held on the 6th day of April, 1953, at the hour of 8 o'clock P. M. on the question of whether or not the following described real property should be annexed to the Town of Stayton.

Beginning on the Section line common to Sections 10 and 11, Township 9 South, Range 1 West of the Willamette Meridian, Marion County, Oregon, said point being 863.58 feet North of the quarter section corner between sections 10 and 11 of said Township and Range; thence North 89° 09' East 1386.00 feet to the East line of a tract of land conveyed to Amandus J. Frank and Louise Frank, by deed recorded in Volume 429, Page 219, Deed Records for Marion County, Oregon; thence North along the East line of said tract 900.00 feet to the Northeast corner of said tract; thence South 89° 09' West along the North line of said tract 92.40 feet to the Southeast corner of a tract of land conveyed to George H. Bell and Abbie M. Bell by deed recorded in Volume 429, Page 542, Deed Records for Marion County, Oregon; thence North 0° 05' East along the East line of said tract 875.16 feet to the Northeast corner of said tract on the North line of Section 11 in said Township and Range; thence South 89° 09' West along the North line of said Section 1294.26 feet to the corner common to Sections 2, 3, 10 and 11 in said Township and Range; thence South on the Section line common to Sections 10 and 11 in said Township and Range 1775.16 feet to the place of beginning.

Section 2. Said Public Hearing is to commence at 8 o'clock P. M. on the 6th day of April, 1953, and it is for the purpose of hearing objections to the proposition of whether or not the above described real property should be annexed to the Town of Stayton, Oregon.

Section 3. The City Recorder is hereby directed to post notice of said hearing at four public places in the Town of Stayton and cause notice of said hearing to be published in the Stayton Mail at least two times preceeding said hearing and said notice shall designate date, time and place of said hearing and the purpose of said hearing as to the proposition of annexation of the herein described property.
