AN ORDINANCE TO REPEAL ORDINANCES NOS. 46, 129, 130, 133, 137, 138, 139, 149, 153,155, 179, 188, 191, 194(2), 194 A, 196, 198 (2), 199 B, 200, 201, 211, $213\frac{1}{2}$, 220, 223, and 238.

The Town of Stayton do ordain as follows:

Section 1. Ordinance no. 46, entitled "A bill for an ordinance to provide the form of poll books and official ballots to be used at all town elections held in the town of Stayton, Marion County, Oregon, and the manner and the time of placing the names of candidates for town officers on such official ballots," passed by the common council of said town on February 21, 1901 shall be and the same is hereby repealed.

Section 2. Ordinance no. 129, entitled, "An ordinance to provide for the good conduct, good order, health, peace and cleanliness of the town, and of persons and for the protection of persons and property and to repeal certain ordinances and parts of ordinances relating thereto, and declaring an emergency to exist," passed by the common council of said town on August 1st, 1916 shall be and the same is hereby repealed.

Section 3. Ordinance no. 130, entitled, "A Bill for an Ordinance to prevent domestic animals from running at large within the Town of Stayton, and to provide for the taking up, impounding and selling of same; and to repeal Ordinances No. 4, 5, 30, 52, 73, 74 and 81 and all ordinances or parts of ordinances in conflict herewith," passed by the common council of said town on August 1st, 1916 shall be and the same is hereby repealed.

Section 4. Ordinance no. 133, entitled "A bill for an ordinance providing for the manner of collection and the payment of fines and penalties imposed for violation of town ordinances, and providing for the working of town prisoners upon the streets, parks, buildings or other property of the town of Stayton, and repealing ordinance no. 8 and all ordinances or parts of ordinances in conflict herewith," passed by the common council of said town on August 1st, 1916 shall be and the same is hereby repealed.

Section 5. Ordinance no. 137, entitled "A bill for an ordinance to regulate the placing and hanging of signs and awnings over, across or on any sidewalk street or alley within the town of Stayton, Oregon; to provide a penalty for the violations of this ordinance; and declaring an emergency to exist," passed by the common council of said town on September 5, 1916 shall be and the same is hereby repealed.

Section 6. Ordinance no. 138, entitled "A bill of an ordinance making it unlawful for the owners of real property within the town of Stayton, Oregon to allow or permit grass, weeds, berry bushes, briars, brush or rubbish to grow or remain in the streets, alleys or other highways abutting upon their property to the center of such street, alley or highway; providing a penalty for violations of this ordinance; repealing ordinances no. 69 and 123; and declaring an emergency to exist," passed by the common council of said town on September 5, 1916, shall be and the same is hereby repealed.

Section 7. Ordinance no. 139, entitled "A Bill for an Ordinance fixing the amount of official bond required of the Recorder, Marshal and Treasurer; providing for approval and filing of same; and repealing Ordinance No. 61," passed by the common council of said town on September 5, 1916 shall be and the same is hereby repealed.

Section 8. Ordinance no. 149, entitled "A bill for an ordinance to regulate the circulation and distribution of hand-bills, circulars, papers, magazines, and other printed or written matter within the town of Stayton, and declaring an emergency to exist," passed by the common council of said town on May 7, 1918 shall be and the same is hereby repealed.

Section 9. Ordinance no. 153, entitled "A bill, for an ordinance providing for the filing of petitions of dandidates for nomination to town offices; prescribing the form of such petitions, and the number of signatures required thereon; fixing the time of holding general primary elections for nomination of candidates to town offices; declaring candidates duly elected under certain conditions; repealing ordinance no. 45, and sections 4,5,6,7,8,8, and 10, of ordinance no. 46; and declaring an emergency to exist," passed by the common council of said town on September 19, 1918 shall be and the same is hereby repealed.

Section 10. Ordinance no. 155, entitled "A bill of an ordinance providing for the enforcement of the rules and regulations of the ex officio board of health of the town of Stayton; providing a penalty for the violation thereof, and declaring an emergency to exist," passed by the common council of said town on January 11, 1919 shall be and the same is hereby repealed.

Section 11. Ordinance no. 179, entitled "An ordinance providing the procedures for submitting and referring amendments to the charter of the town of Stayton, or other measures, to the voters of said town, by the council of said town; providing the method of conducting elections to vote on such measures; repealing ordinance no. 159 and all acts and parts of acts in conflict herewith; and declaring an emergency to exist," passed by the common council of said town on November 1st, 1922 shall be and the same is hereby repealed.

Section 12. Ordinance no. 188, entitled "A bill for an Ordinance to amend ordinance 130 entitled 'An ordinance to prevent domestic animals running at large within the town of Stayton, and to provide for the taking up and impounding the same; and to repeal ordinances no. 4, 5, 30, 52, 73, 74 and 81, and all ordinances or parts of ordinances in conflict herewith, and to declare an emergency to exist." passed by the common council of said town on May 3, 1924, shall be and the same is hereby repealed.

Section 13. Ordinance no. 191, entitled "For an ordinance to regulate public billiard and pool rooms, and to prohibit owners, keepers or other persons in charge of such rooms from allowing minors therein, and to fix the hour of closing the same, and providing a penalty for violations of this ordinance, and to repeal all of ordinance no. 164, passed by the council on July the 5th, 1921, and declaring an emergency to exist," passed by the common council of said town on July 7, 1925 shall be and the same is hereby repealed.

Section 14. Ordinance no. 194(2), entitled "A Bill for an Ordinance, to license and regulate public dances, and dance halls within the Town of Stayton, Oregon, and to repeal all of Ordinance No. 157, passed by the Council and approved by the Mayor October 7, 1919, entitled an Ordinance regulating public dance halls in the Town of Stayton Oregon. Providing a penalty, and declaring an emergency to exist, and to repeal parts of ordinances in conflict with this Ordinance, And to provide penalties for violations of this ordinance, And Declaring an emergency to exist," passed by the common council of said town on November 9, 1926, shall be and the same is hereby repealed.

Section 15. Ordinance no. 194 A, entitled "A bill for an ordinance to amend ordinance no. 129, entitled an ordinance to provide for the good conduct, good order, health, and cleanliness, of the town and of persons, and for the protection of persons and property, and to repeal certain ordinances and parts of ordinances relating thereto, and declaring an emergency to exist," passed by the common council of said town on March 29, 1926 shall be and the same is hereby repealed.

Section 16. Ordinance no. 196, entitled "An ordinance amending ordinance no.179 heretofore passed by the council of the town of Stayton, and declaring an emergency," passed by the common council of said town on May 10, 1926 shall be and the same is hereby repealed.

Section 17. Ordinance no.198, (2), entitled "A bill for an ordinance to regulate the placing of obstructions on the streets, alleys or walks within the town of Stayton, Oregon, and to provide for their removal, and provide penalties for violations of this ordinance. And to repeal all ordinances or parts of ordinances in conflict with this ordinance, and declaring an emergency to exist," passed by the common council of said town on May 3rd, 1927 shall be and the same is hereby repealed.

Section 18. Ordinance no. 199 B, entitled "A bill for an ordinance to license, tax and regulate certain callings and occupations within the town of Stayton, Oregon, prescribing the character of said license, and manner of issuing, and collecting the same; fixing penalties and restrictions in relation thereto; and repealing all of ordinance no 131, recorded on page 82 of the book of ordinances, and passed the council August 1st, 1916, and all ordinances and parts of ordinances in conflict with this ordinances and to declare an emergency," passed by the common council of said town on August 2nd, 1927 shall be and the same is hereby repealed.

Section 19. Ordinance no. 200, entitled "A bill for an ordinance to amend section 15 of ordinance number 129 of the town of Stayton, Oregon, providing for the good conduct, order, peace and safety of said town, and providing punishment for the violation of such ordinance," passed by the common council of said town on November 6th, 1931 shall be and the same is hereby repealed.

Section 20. Ordinance no. 201, entitled "A bill for an ordinance providing for the assessment of costs upon conviction of violation of any ordinance of the town of Stayton; providing for imprisonment upon failure to any fine assessed for violation of any ordinance; and providing for the working of any person sentenced to imprisonment upon violation of any ordinance," passed by the common council of said town on November 6th, 1931 shall be and the same is hereby repealed.

Section 21. Ordinance no. 211, entitled "A bill for an ordinance to provide for the regular and special meetings of the council of the town of Stayton, Oregon, repealing ordinances in conflict herewith, and declaring an emergency to exist," passed by the common council of said town on October 3, 1933 shall be and the same is hereby repealed.

Section 22. Ordinance no. 2132, entitled "An ordinance to provide for the licensing, regulation and control of the manufacture of, and traffic in, alcoholic beverages; to define offenses and the punishment thereof; repealing other ordinances in conflict herewith; and declaring an emergency," passed by the common council of said town on May 7, 1934 shall be and the same is hereby repealed.

Section 23. Ordinance no. 220, entitled "AN ORDINANCE to license and regulate certain games of skill within the Town of Stayton; to provide penalties for the viblation of this ordinance; to repeal conflicting ordinances; and declaring an emergency," passed by the common council of said town on April 23, 1936 shall be and the same is hereby repealed.

Section 24. Ordinance no. 223, entitled "An ordinance to amend section 4 of ordinance no. 220; and declaring an emergency," passed by the common council of said town on March 31, 1937 shall be and the same is hereby repealed.

Section 25. Ordinance no. 238, entitled "An ordinance to amend section fourteen of ordinance number $213\frac{1}{2}$ fixing the hours within which alcoholic liquors may be sold," passed by the common council of said town on July 12, 1940 shall be and the same is hereby repealed.
