ORDINANCE NO. 925

AN ORDINANCE AMENDING AND RESTATING THE STAYTON MUNICIPAL CODE, CHAPTER 12.08 (STANDARD SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTION)

WHEREAS, Stayton Municipal Code (SMC) Title 12 provides for the adoption of public works design standards and construction specifications for streets, water, sanitary sewer and storm drainage facilities owned and operated by the City of Stayton;

WHEREAS, the City's standard specifications for public works design and construction were last updated in 1994; and

WHEREAS, the City retained John Ashley, PE, to update the City's design standards and construction specifications to reflect changes in policy, procedure, new technology, design methods and construction methods; and

WHEREAS, the City's Public Works Department has completed an 18-month review of the public works design standards and construction specifications including a review of the draft standards by city staff, private contractors and design professionals; and

WHEREAS, the City staff has provided copies of the proposed City of Stayton Design Standards and Construction Specifications, 2010 Edition, to the City Council for consideration; and

WHEREAS, on June 7, 2010, the City Council agreed it is appropriate that the current Chapter 12.08 of Title 12 SMC be repealed and substituted by a restated Chapter 12.08 of Title 12 SMC which adopts the City of Stayton Design Standards and Construction Specifications, 2010 Edition, as set forth in Exhibit A which is attached hereto and made a part hereof.

NOW, THEREFORE, the City of Stayton ordains as follows:

SECTION 1. Stayton Municipal Code, Chapter 12.08 of Title 12 is hereby repealed in its entirety whereupon the restated Chapter 12.08 of Title 12 SMC, as set forth in Exhibit A, attached to this ordinance and incorporated herein, is hereby adopted.

SECTION 2. Upon adoption by the Stayton City Council and Mayor's signing, this Ordinance shall become effective 30 days after the date of signing.

12.08.310 ADOPTED, CONFORMANCE REQUIRED, AMENDMENT

- The City has adopted a certain set of documents entitled "City of Stayton Public Works Design Standards and City of Stayton Construction Specifications – 2010 Edition" as the public works design standards and construction specifications for public works improvements in the City.
- 2. All public works design and construction, including workmanship and materials, shall be in accordance with the current edition of the City of Stayton Public Works Design Standards and Construction Specifications. This section applies to all public improvements within the city limits of the City of Stayton, the Stayton Urban Growth Boundary or as otherwise required by law.
- 3. The Public Works Director will periodically update the City of Stayton Public Works Design Standards and Construction Specifications to reflect changes in policy, procedure, new technology, design methods and construction methods.
 - a. Requests for modifications may be initiated either by the City or by an interested party.
 - b. Requests for modifications will be considered in accordance with the review procedures set forth in the City of Stayton Design Standards and Construction Specifications.

TITLE 12. STREETS, SIDEWALKS, AND PUBLIC PLACES

- c. The Public Works Director is hereby granted authority to approve or deny requests for modifications to the City of Stayton Design Standards and Construction Specifications.
- d. Updates to the City of Stayton Public Works Design Standards and Construction Specifications will be posted on the City's website. Copies may be purchased from the City.
- e. The Public Works Director will provide the City Council with a semiannual report which lists the updates and modifications made to the City of Stayton Public Works Design Standards and Construction Specifications during the preceding six months.
