#### **ORDINANCE NO. 976**

AN ORDINANCE AMENDING THE STAYTON MUNICIPAL CODE TITLE 2 CHAPTER 2.64 DISPOSITION OF UNCLAIMED PERSONAL PROPERY; REPEALING SMC 2.64.1600-2.64.1650 (ORD. NO. 658), SMC 2.64.1670 (ORD NO. 700), AND SMC 2.64.1660 (ORD NO. 874)

Whereas, ORS 98.245, and the related Oregon Administrative Rules establish rules and procedures for disposition of unclaimed property; and

Whereas, Title 2 Chapter 2.64, needs to be updated to reflect the current ORS 98.245; and

Whereas, SMC 2.64.1600-2.64.1650, Ordinance 658, References to prior code section 2.230; and

Whereas, SMC 2.64.1670, Ordinance No. 700, Disposal of surplus property needs to be repealed in its entirety; and

Whereas, SMC 2.64.1660, Ordinance No. 874 Section 18, Sale of city owned surplus property, needs to be repealed;

NOW THEREFORE, the City of Stayton ordains:

SECTION 1. Stayton Municipal Code Title 2 "Administration and Personnel," Chapter 2.64 "DISPOSITION OF PERSONAL PROPERTY" is hereby amended to read:

2.64 Disposition of unclaimed personal property

2.64.1600 Personal property taken into the custody of any department by reason of seizure, abandonment, or for any other reason shall be disposed of per ORS 98.245.

SECTION 2. SMC 2.64.1600-2.64.1650 (ORD. NO. 658), SMC 2.64.1670 (ORD NO. 700), AND SMC 2.64.1660 (ORD NO. 874) are hereby repealed. Upon enactment by the Stayton City Council and the Mayor's signature, the Ordinance shall become effective 30 days after enactment.
