ORDINANCE NO. 892

AN ORDINANCE AMENDING STAYTON MUNICIPAL CODE (SMC) TITLE 12 "STREETS, SIDEWALKS, AND PUBLIC PLACES" CHAPTER 12.08, "STAYTON SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTION", SECTION 12.08.310 (3), RELATING TO ADOPTED, CONFORMANCE REQUIRED, AMENDMENT AND DECLARING AN EMERGENCY.

WHEREAS, the Stayton Municipal Code (SMC) Title 12.08 provides for Standard Specifications for Public Works Construction; and SMC Section 12.08.310 (3) presently requires amendments in the Standard Specifications be recommended by the Public Works Director and approved by the City Council by Ordinance.

WHEREAS, it is the City Council's desire to amend SMC Title 12.08.310 (3) to approve standard specification amendments by Resolution; and

WHEREAS, it is appropriate that an emergency be declared as to the enactment of this Ordinance so that it is in full force and effect immediately from and after its adoption by the Stayton City Council.

NOW, THEREFORE, the Stayton City Council does ordain as follows

SECTION 1. Stayton Municipal Code Title 12 "STREETS, STDEWALKS, AND PUBLIC PLACES", Chapter 12.08 "STAYTON SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTION", SECTION 12.08.310 "RELATING TO ADOPTED, CONFORMANCE REQUIRED, AMENDMENT" is hereby amended and restated to read:

12.08.310 ADOPTED, CONFORMANCE REQUIRED, AMENDMENT

- 1. A certain set of documents entitled "Standard Specifications for Public Works Construction in the City of Stayton, Oregon" (September, 1994), prepared by the consulting engineer for the city, is adopted as the standard specifications for public works construction in the city. A copy of the specifications is available for inspection or purchase at Stayton City Hall.
- 2. All work done and materials used for public improvements shall conform to the city's standard specifications unless otherwise provided for in the particular specifications for work as approved by the public works director or city engineer.
- 3. Amendments in the standard specifications shall be recommended by the public works director and approved by the council by resolution.

SECTION 2. EMERGENCY CLAUSE Upon adoption by the Stayton City Council and the Mayor's signing, this Ordinance shall become immediately effective.
