AN ORDINANCE PROVIDING FOR THE CALLING OF A CITY TAX BASE ELECTION IN THE CITY OF STAYTON, OREGON, ON MAY 25, 1976, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE CITY THE QUESTION OF ESTABLISHING A NEW TAX BASE.

WHEREAS, the city council of the city of Stayton, Oregon, has determined that a new tax base should be established as authorized by subsection (2), Section 11, Article XI, of the Oregon Constitution, and

WHEREAS, it is necessary to submit the question of establishing a new tax base to the legal voters of the city of Stayton, Oregon,

NOW, THEREFORE,

THE CITY OF STAYTON ORDAINS AS FOLLOWS:

Section 1. <u>Date of Election</u>. The proposition set forth in Section 2 of this ordinance shall be submitted in the manner prescribed herein to the legal voters of the city of Stayton, Oregon, at a city tax base election to be held concurrently with the regular statewide primary election being held in the State of Oregon on May 25th, 1976.

Section 2. Form of Proposition. At the city tax base election there shall be submitted to the legal voters of the city of Stayton for their approval or rejection, the following proposition:

"Shall the city of Stayton, Marion County, Oregon increase its tax base from \$15,760.00 now in effect to a new base of \$195,736.00."

Section 3. The city tax base election shall be handled by the same election boards that handle the regular statewide primary election. Such election boards are herebesignated as the election boards

This proposition, if adopted, will establish a new tax base for the city of Stayton, Oregon, for the purpose of applying the limitation on taxation set forth in Section 11, Article XI, Oregon Constitution. The present tax base is \$15,760.00 the new tax base if adopted will be \$195,736.00 , and the new tax base if adopted shall first apply to the fiscal year next following this election.

The polling places for Precints #75 and #76, comprising the City of Stayton and the election officers will be the same as provided for the statewide primary election to be held on the same day, May 25, 1976.
