ORDINANCE NO. 479

An Ordinance declaring assessments on property benefited, for the cost of construct paving on West MAPLE STREET, from Evergreen Avenue Westerly to Fern Avenue, also EVERGREEN AVENUE from Water Street South 260 feet and Douglas Avenue from Washington Street North to Locust Street, in the City of Stayton, Oregon; and directing the City Recorder to enter such assessments against each lot, part of lot and parcel of land benefited therefor in its proportionate share in the Lien Docket of the City of Stayton; directing the service of notice of said assessments, upon the owners of such property, and declaring an emergency.

THE CITY OF STAYTON ORDAINS AS FOLLOWS:

Section 1. That the common council hereby declares that it has found it necessary and expedient to improve MAPLE STREET, from Evergreen Avenue westerly to Fern Avenue; EVERGREEN AVENUE from Water Street South 260 feet and DOUGLAS AVENUE, from Washington Street north to Locust Street, that portion which lies in the City of Stayton, Oregon by paving in accordance with plans, specifications and estimates heretofore duly and regularly adopted by the Common Council, which are hereby referred to and made a part hereof.

WHEREAS, a meeting of the City Council was held at the time and place fixed by public notice for the purpose of considering any such protest and at that time heard and considered all protest submitted ralating to the proposed improvement and assessment thereof, and said Council has considered the matter and deeming that said construction of said improvement was and is of material benefit to the City, and all the property to be assessed therefore will be benefited thereby to the extent of the probable amount of the respective assessment to be levied against said property, did order the construction of said improvements, and;

WHEREAS, the cost of said improvements has been and hereby is determined to be the sum of \$31,062.92 for said MAPLE STREET and EVERGREEN AVENUE improvement and \$19,242.45 for said DOUGLAS AVENUE improvement.

NOW, THEREFORE, it is hereby determined that the proportionate share of the cost of construction of said improvement, on each parcel of property adjacent to said improvement and benefited thereby is the amount set opposite the description of each piece or parcel of land benefited by the construction of said improvements, to the full extent of the amount so set opposite such piece, or parcel, and that the respective amounts represent the proportional benefits of said improvements to said respective parcels of property, and the council does hereby declare that each of the parcels of property described below is hereby assessed the amount set opposite each respective description, for the cost of construction of said improvements.

Section 6. It is hereby adjudged and declared that existing conditions are such that this Ordinance is necessary for the immediate preservation of the public peace, health, and safety; and, owing to the urgent necessity of maintaining the public credit, an emergency is declared to exist, and
