## ordinance no. 381

AN ORDINANCE AMENDING ORDINANCE NO. 248, RELATING TO DEFINING AND PUNISHING CERTAIN OFFENSES AGAINST THE PUBLIC PEACE, SAFETY, MORALS AND GENERAL WELFARE BY AMENDING CERTAIN SECTIONS THEREOF, AND DECLARING AN EMERGENCY.

THE CITY OF STAYTON DO ORDAIN AS FOLLOWS:

Section 1. Section 47 of Ordinance No. 248 is hereby amended by deleting the language therein contained and substituting therefore the following language:

"Section 47. SIDEWALKS, DRIVING ON.

- (a) It shall be unlawful for any person to ride or drive any horse or other animal or any motor vehicle upon, over, or across any sidewalk except where a proper incline or crossing is provided for that purpose.
- (b) It shall be unlawful for the operator of any vehicle to drive, stop or park such vehicle in any parking area or lot which is open to the public in such a manner so as to prevent, interrupt, or obstruct the free access to and from such area or lot, or to prevent, interrupt or obstruct the free passage through such area or lot along any lane or way marked or used for such passage.
- Section 2. Section 52 of Ordinance No. 248 is hereby amended by deleting the language therein contained and substituting therefore the following language:

"Section 52. STREETS AND SIDEWALKS, OBSTRUCTING.

(a) It shall be unlawful for any person to place or deposit any article upon, or for the operator of any vehicle to stop, park or place such vehicle upon, any street, sidewalk, parking area or lot, which tends to prevent, interrupt or obstruct the travel or free passage of pedestrians or vehicular traffic, except where necessary to protect the public welfare or safety.

to stop or park such vehicle in any parking area or lot which is open to the public, or upon any street or highway, except where such vehicle is within designated lines or markers indicating individual parking stalls, except as may be necessary for the public safety. In the event no such lines or markers exist, the operator of any vehicle shall stop or park such vehicle only in such a manner so as to permit free passage of pedestrians or other vehicles upon such street, parking area or lot."

Section 3. Section 62 of Ordinance No. 248 is hereby amended by deleting the language therein contained and substituting therefore the following language:

"Section 62. INJURIOUS SUBSTANCES, DEPOSIT ON STREETS. It shall be unlawful for any person to place or deposit upon any street, sidewalk, parking area or lot which is open to the public, any substance tending to mar the appearance or to detract from the cleanliness or safety of such street or public way."

Section 4. Section 7 of Ordinance No. 248 is hereby amended by deleting the language therein contained and substituting therefore the following language:

"Section 7. AFTER HOURS.

- (a) It shall be unlawful for any person to be upon the extreets at late or unusual hours of the night without having any lawful business or occasion to be upon such streets at said time.
- (b) It shall be unlawful for any person to loiter in or near any vehicle stopped or parked in any place open to the public without having any lawful business or occassion for such loitering.
- (c) It shall be unlawful for any person to loiter, regardless of whether in or near a vehicle, in any place open to the

public whenever such area has been posted by the owner thereof or by the appropriate public agency, that loitering is prohibited, or when such person has been ordered to move on by any police officer."

Section 5. Ordinance No. 248 is hereby amended by adding thereto a section No. 79A, as follows:

"Section 79A. RECKLESS DRIVING.

It shall be unlawful for any person to drive any vehicle upon a street, highway or in or upon any public park, parking lot or other place open to the public carelessly or heedlessly in wilful or wanton disregard of the rights, privileges or safety of others."

Section 6. Inasmuch as this ordinance is necessary for the immediate protection of the public peace, welfare and safety of the City of Stayton, an emergency is hereby declared to exist and this ordinance shall be in full force and effect immediately from and after its passage by the council and approval by the mayor.
