

ORDINANCE NUMBER 385

An Ordinance vacating a portion of North Third Avenue between Cedar Street and Fern Ridge Road in the City of Stayton, Oregon, AND  
*DECLARING AN EMERGENCY.*

WHEREAS, that portion of North Third Avenue between Cedar Street and Fern Ridge Road in the City of Stayton, has been straightened and relocated and is no longer being used as a public street, and

WHEREAS, no objections have been presented at the public hearing or otherwise regarding such vacation, now therefore,

THE CITY OF STAYTON DOES ORDAIN AS FOLLOWS:

Section 1. That portion of North Third Avenue between Cedar Street and Fern Ridge Road, in the City of Stayton, Oregon, more particularly described as follows, to-wit:

Beginning at the Westerly Northwest corner of Lot 7, Annex No. 2 to Hollister's Addition in Township 9 South, Range 1 West of the Willamette Meridian in Stayton, Marion County, Oregon; thence North 6° 26' East 81.22 feet on a line between said point of beginning and the Southwest corner of the premises described in Volume 37, Page 29, Deed Records for Marion County, Oregon; thence North 89° 07' East 45.77 feet on an extension of the Southerly line of Regis Street to a point on the Westerly line of said Lot 7; thence South 3° 27' West to a re-entrant corner of said Lot 7; thence Westerly 50 feet to the place of beginning and containing 0.09 acres.

ALSO Beginning at the Southwest corner of the premises described in Volume 37, Page 29, said point being situated 9 chains East and 6.67 chains South of the Quarter section corner between Sections 3 and 10, Township 9 South, Range 1 West of the Willamette Meridian in Marion County, Oregon; thence South 6° 26' West 221.42 feet on a line between said point of beginning and the Westerly Northwest corner of Lot 7, Annex No. 2 to Hollisters Addition; thence North 89° 07' East 42.56 feet on an extension of the Northerly line of Regis street to the Westerly line of said Lot 7; thence North 3° 27' East 220.25 feet to the Northerly Northwest corner of said Lot 7; thence South 89° 37' West 31.00 feet, more or less, to the place of beginning and containing 0.18 acres.

Section 2. That portion of North Third Avenue between Cedar Street and Fern Ridge Road as described in Section 1 above shall be and hereby is vacated.

Section 3. It is hereby adjudged and declared that the existing conditions in the City of Stayton are such that this ordinance is necessary for the immediate preservation of the public peace, health and safety, and an emergency hereby is declared to exist, and this ordinance shall take effect and be in full force and effect from and after its passage.
