Ordinance No. 118

A Bill for an Urdinance providing for the assessment of the actual cost of improving west water Street in Stayton, Uregon, from the West line of 1st. Street to the West line of Burson's Addition to Stayton, Uregon, against the property adjacent to and abutting upon the said portion of said Water Street; declaring the proportionate share of the actual cost of making the improvement of said street to be charged and assessed against each lot or part thereof or parcel of land adjacent to or abutting upon the said portion of said Water Street, which is liable for the assessment and cost of making the said improvement and directing the recorder of the Town of Stayton, Uregon, to make an entry of such proportionate share of the cost of making said improvement in the Docket of Town Liens, and declaring an emergency to exist.

THE TOWN OF STAYTON DO ORDAIN AS FOLLOWS:

Section 1. That the Common Council of the Town of Stayton, Oregon, hereby declare that it is necessary and expedient to improve West Water Street in the Town of Stayton, Oregon, from the West line of 1st. Street to the West line of Burson's Addition to Stayton, Oregon, in accordance with the plans, specifications and estimates for making said improvement heretofore adopted by the Common Council and on file in the office of the Town Recorder, which said plans and specifications are hereby referred to and made a part of this ordinance.

Section 2. That the actual cost of making the improvement of west water Street from the west line of lst. Street to the West line of Burson's Addition to Stayton, Oregon, has been ascertained and determined including a sum not exceeding 5% of the total contract price added for engineering expenses acquiring descriptions of property and other expenses connected with the making of said improvement after the execution of the contract and bond authorized and directed to be executed by the Mayor and Recorder, which said actual total cost of making such improvement is hereby declared to be the sum of \$624.90, which said total actual cost is hereby assessed against the lots or parts thereof, or parcels of land adjacent to or abutting upon said West water Street within the limits of said improvement. That the proportionate share of the total cost of improving the said portion of said West water Street, for which each lot or part thereof or parcel of land is liable, has been ascertained and determined by the Common Council of the Town of Stayton, Oregon, and said Common Council hereby adjudges and declares that each lot or part thereof, or parcel of land hereinafter described in Section 4 of this ordinance is benefited by the making of said improvement in the full sum of money set opposite the description of said lot or part thereof, or parcel of land in said Section 4, and the said total actual cost of making the said improvement is hereby declared to be the aggregate of the sums specified in said Section 4, and the said sum set opposite the descriptions of the lots or parts thereof, or parcels of land contained in said Section 4 are hereby assessed upon and against each lot or part thereof, or parcel of land as indicated and described in said Sections 4, of this Ordinance.

Section 3. That the Recorder of the Town of Stayton, Oregon, is hereby authorized and directed to enter a statement of all of the assessments made by this Ordinance in the Docket of Town Liens of the Town of Stayton, Oregon, as provided for in the Charter of said town.

Section 4. That the following tabulated statement of names, descriptions and amounts contains a description of the property designated and assessed by Section 2 of this Ordinance, and which is liable for the total actual cost of making said improvement, and also the names of the persons who appear to be the respective owners of said property and the assessments of the respective and proportionate share of the costs of making the said improvement assessed against each lot or part thereof, or parcel of land liable under the charter of the said Town of Stayton, for making said improvement, to-wit:
