## ORDINANCE No. 143.

A. Bill for an Ordinance withdrawing and excepting all the territory within the limits of the Town of Stayton, Oregon as now existing or as may be hereafter extended, out of Road District No.32, and out of the jurisdiction of the County Court of Marion County, Oregon; declaring and constituting the Town of Stayton, Oregon a seperate Road District extending to and within its own corporate limits; exempting the inhabitants of the Town of Stayton and the property within the city limits from tax assessments for road work except when levied by the city council; providing for the control, disposition and direction of all funds collected under the general laws for the improvements of roads and streets; repealing all Ordinances and parts of Ordinances in conflict herewith; and declaring an emergency to exist and that this Ordinance shall go into effect and become operative immediately upon its passage by the Council and approval by the Mayor.

## THE TOWN OF STAYTON DO ORDAIN AS FOLLOWS:

SECTION 1. That the territory within the limits of the Town of Stayton, Oregon as now existing or as may be hereafter extended, be and the same is hereby withdrawn, taken, and excepted from and out of Road District No. 32, and out of the jurisdiction of the County Court of Marion County, Oregon.

SECTION 2. That the territory described in Section No. one of this Ordinance be and the same is hereby declared to be and is constituted a seperate Road District extending to and covering the corporate limits of the Town of Stayton.

SECTION 3. That the inhabitants of the Town of Stayton and the property within its limits shall be and are exempt from tax assessments for road work except as may be levied ans assessed by the city council.

SECTION 4. The council shall have power to levy and assess taxes, and the exclusive control, disposition and direction of all funds collected under the general laws for the improvements of roads and streets within said constituted Road District or said corporation and the Street Commissioner shall perform the duties of Supervisor as required by the laws of the State relating to streets and highways; providing that the City Council shall, by ordinance, direct that such funds collected be expended on roads and streets within the corporate limits of Stayton, Oregon.

SECTION 5. That all Ordinances and parts of Ordinances in conflict herewith be, and the same are hereby repealed.

SECTION 6. Whereas there is a considerable amount of County Road money in the Marion County Treasury which money is obtainable by and may be expended within the limits of the newly constituted Road District described in Section No, two providing immediate action is taken by the council of Stayton, Now Therefore, it is the judgement of the council that an emergency exists, and that it is necessary for the immediate benefit of the Town of Stayton, Oregon that this Ordinance shall go into effect and become immediately operative upon its passage by the Council and approval by the Mayor.
