ORDINANCE NO. 162.

A BILL for an Ordinance providing for the Assissment of the Actual cost of improving West Water Street in the town of Staytonm, Oregon, from the East li ne of First Street to the West line of Second Street in Bursons Addition to Stayton, Oregon against the property adjacent torand abutting upon the said portion of West Water Street; declaring the proportionate share of the actual cost of making the improvement of said street to be charged and assessed against each lot or part thereof or parcel of land adjacent to or abutting upon the said portion of said Water Street, which is liable for the assessment and cost of making the said improvement and directing the Recorder of the town of Stayton, Oregon, to make an entry of such proportionate share of the cost of making said improvement in the docket of town Liens, and declaring an emergency to exist.

THE TOWN OF STAYTON DO ORDAIN AS FOLLOWS:

That the Council of the Town of Stayton, Oregon, hereby Section 1. declare that it is necessary and expedient to improve West Water Street in the town of Steyton, Oregon, from the East Line of 1st Street to the West Line of Second Street in Bursons Addition to Stayton. Oregon, in accordance with the plans specifications and estimates for making said improvements heretofore adopted by the Council and on file in the Office of the town Recorder, which plans and specifications are hereby refered to end made a part of this ordinance, to wit;

That portion of West Water Street beginning at the East line of 1st

Street and extending West to the West line of 2d Street in Bursond Addition to the town of Stayton, shall have the Grade restored by scraping Earth from the sides MN of themstreet to form a crown of 16 inches in the center of said street, a sub grade shall be made extending 42 feet on each side of the center line of the street, with sholders sufficient to recleve 8 inches of gravel, upon such sub grade shall be placed a layer of coarse gravel not exceeding 3g inches in diameter 4 inches deep, extending from the sholder to the inside of the wheel track a distance of 3 feet; upon this layer of coarse gravel shall be placed alayer of Screened gravel 4 inches deep extending from sholder to sholder of the sub grade, said screened gravel shall pass through a screen with meshes not exceeding la inches square.

That the actual cost of making the improvement of West Water Section 2. Street from the East line of lat street to the West line of Second Street in Bursons Addition to Stayton, Oregon, has been ascertained and determined including a sum not exceeding 5% of the total contract price added for engineering expenses acquiring descriptions of proprty and other expenses connected with the making of said improvement after the execution of the contract and hond authorized and directed to be executed by the Mayor and Recorder, which actual Cost of making such improvement is hereby declared to be the sum of \$ 529.55 which said total actual cost is hereby assessed against the lots or parts thereof, or parcels of land adjacent to or abutting upon said West Water Street within the limits of said improvement. That the proportionate share of the total cost of improving the said portion of said West Vater Street, for which each lot or part the said portion of said is liable, has been ascertained and determined by the Council of the town of Stayton, Oregon, and said Council hereby adjudges and declares that each lot or part thereof or parcel of land hereinafter described in Section 4 of this ordinance is benefited by the making of said improvement in the full sum of money set oposite the description of said lot or part thereof, or parcel of land in Section 4 and the said total actual cost of making the said improvement is hereby declared to be the agregate of the sums specified in said section 4, and the said sum set oposite the description of the lots or parts thereof or parcels of land contained in said section 4 are hereby assessed upon and against each lot or part thereof, or parcel of land as inDIcated and described in said section 4 of this ordinance.

Section 3, That the Recorder of the Town of Stayton, Oregon, is hereby authorized and directed to enter a statement of all the assessments made by this ordinance in the Docket of Town Liens of the Town of Stayton, Oregon, as provided for in the Charter of said Town.

Section 4. That the following tabulated Statement of Names, Descriptions and amounts, contains a description of the property designated and assessed by Section 2 of this Ordinance, and which is liable for the total actual cost of making said improvement, and also the names of the persons who appear to be the respective owners of sair property and the assessment of thr respective and proportionate share of the costs of making the said improvement assessed against each Lot or part thereof or percel of land liable under the Charter of the said Town of Stayton, for making said improvement, to-wit;
