ORDINANCE NO 163.

A BILL

FOR AN ORDINANCE GRANTING UNTO WALTER ROSS, HIS HEIRS AND ASSIGNS, THE RIGHT AND FRANCHISE TO ERECT AND MAINTAIN POLES, TO STRING WIRES, BOTH UNDER GROUND AND OVER HEAD, AND TO INSTALL AND MAINTAIN OTHER NECESSARY EQUIPMENT FOR THE TRANSMISSION OF ELECTRICITY THROUGH AND ACROSS THE TOWN OF STAYTON, OREGON, UPON CERTAIN STREETS IN SAID TOWN AND FOR THE TRANSMISSION OF ELECTRICITY INTO, WITHIN AND FROM SAID TOWN, FOR THE PRIVATE USE OF SAID WALTER ROSS, HIS HEIRS AND ASSIGNS; AND TO CONSTRUCT OPERATE AND MAINTAIN ELECTRIC SUB STATIONS AND POWER PLANTS WITHIN SAID TOWN, AND TO DO ANY AND ALL OTHER ACTS OR THINGS NECESSARY TO CARY OUT THE PURPOSE OF THIS FRANCHISE, SUBJECT, HOWEVER, TO THE CONDITIONS AND LIMITATIONS SPECIFIED IN THIS ORDINANCE.

THE TOWN OF STAYTON DO ORDAIN AS FOLLOWS:

Section 1. The Town of Stayton does hereby hrant to Walter Ross, his heirs and assigns, the right and privilage to string wires, to erect and maintain poles, under ground conduits, overhead supports, all appliances and other equipment necessary or proper for the transmission of electricity through or across the town of Stayton, Oregon, upon, under, over, above, and across Washington Street, from the West City limits of said town, to Seventh street; thence North one Block to Jefferson Street; thence East on Jefferson street to the City limits of said town; also, on first street from the North city limits to Washington Street; also, along Third street from Washington Street South to Water Street, and thence West on Water Street to First Street thence South on First Street to the South City limits of said Town, And in connection with the foregoing, to construct, operate and maintain electric substations and power plants within said town, The said Town of Stayton does also hereby grant unto the said Walter Ross, his Heirs and assigns, the right and privilage of transmitting electricity into, within and from said town for the private ~~mm~~ or individual of the said Walter Ross, his Heirs or assigns, to be used for the maintainance and pperation of any business or establishmnet entirely owned by the said Walter Ross, his Heirs or assigns, PROVIDED, however that none of such electricity so transmited into; within or from said town shall be used therein by any person, firm or corporation who does not own the franchise herein granted in its entirety; PROVIDED however, that the said Walter Ross or his assigns may furnish electricity for domestic use without compensation to his or their bona fied employes,

Section 2, The rights and privilages and franchise herein granted are upon the condition that the said Walter Ross shall within fifteen (15) days after the passage of this Ordinance, make, execute and deliver to the Recorder of the town of Stayton his acceptance in writing of the same.

Section 3, The said Walter Ross, his heirs or assigns, Shall within one year from the date of the passage of this Ordinance, have erected and in operation poles, wires, conduits, and equipment above mentioned, and shall be actualy transmitting electricity through, into, or from said town within said time, over and upon the streets above mentioned, and in case of failure so to do, this ordinance shall be void, without any further act on the part of the Council of said town; PROVIDED, however, if the construction work essential to sucessful and practical carryong of electricity through said town shall have been substantially compleeted within one year from the date of the passage of this ordinance, but the actual completion of the same shall have been prevented on account of unavoidable causes then and in that case a reasonable time shall be allowed for the completion of such work.

Section 4, The right, privilage and franchise hereby granted shall commence on the Date of the approval of this ordinance by the Mayor of said town, and shall be and remain in full force and effect for the term of Forty years from and after said date subject, however to the conditions set forth in Section 3 of this ordinance, and subject

to the further condition that this franchise be used continuously and regularly and without interruption for the uses and purposes for which the same is granted.

PASSED by the Council this 5th day of July 1921.
APPROVED by the Mayor this 7th day of July 1921.
