#### ORDINANCE NO. 522

AN ORDINANCE DECLARING ASSESSMENTS on property benefited, for the cost of construction of the West ten (10) feet of Gardner Avenue from Shaff Road to Locust Street in the City of Stayton, Oregon; and directing the City Administrator to enter such assessments against each lot, part of lot and parcel of land benefited therefore in its proportionate share in the Lien Docket of the City of Stayton; directing the service of said assessments upon the owners of such property and declaring and emergency.

# THE CITY OF STAYTON ORDAINS AS FOLLOWS:

<u>Section 1</u>. That the Common Council hereby declares that it has found it necessary and expedient to improve the West ten (10) feet of Gardner Avenue from Shaff Road to Locust Street in accordance with plans, specifications and estimates heretofore duly and regularly adopted by the Common Council, which are hereby referred to and made a part hereof.

WHEREAS, a meeting of the City Council was held at the time and place fixed by public notice for the purpose of considering any such protest and at that time heard and considered all protest submitted relating to the proposed improvement and assessment thereof, and said Council has considered the matter and deeming that said construction of said improvement was and is of material benefit to the City, and all the property to be assessed therefore will be benefited thereby to the extent of \$4.71 per front foot, did order the construction of said improvements, and;

WHEREAS, the actual cost of said improvements has been and hereby is determined to be the sum of \$27,739.64 for said Gardner Street improvement, with the total assessable cost being \$26,429.22, and the total assessable footage being 5,611.30 lineal feet.
