RESOLUTION NO. 566

A RESOLUTION AUTHORIZING THE TRANSFER OF THE CABLE TELEVISION FRANCHISE FROM NORTHLAND CABLE PROPERTIES EIGHT TO SCS COMMUNICATIONS AND SECURITY, INC.

- WHEREAS, The City of Stayton, hereinafter "City," a municipality situated in Marion County, Oregon, acting by and through its mayor and city council, passed and enacted Ordinance No. 643, hereinafter "Franchise," granting to Northland Cable Properties Eight, the authority to construct, operate, and maintain a cable television system within the city; and
- WHEREAS, Northland Cable Properties Eight intends to sell, transfer, and convey all of its assets, including all of its right, title, and interest in the Franchise, to SCS Communications and Security, Inc.; and
- WHEREAS, It is in the best interests of the City and its citizens to consent to the assignment and transfer of the Franchise to SCS Communications and Security, Inc.;

NOW, THEREFORE, the Stayton City Council hereby resolves as follows:

- 1. The Stayton City Council, hereinafter "Council," hereby approves and consents to the transfer and assignment of the Franchise from Northland Cable Properties Eight, Ltd. to SCS Communications and Security, Inc.
- 2. The Council hereby approves the encumbrances of the Franchise and assets of the cable television system, and the assignment of same for security purposes, in connection with the acquisition and operation of the system assets and the Franchise by SCS Communications and Security, Inc.
- 3. Except as specifically set forth herein, this consent of the Council shall not alter, affect, or otherwise change any of the terms and conditions of the Franchise.
- 4. In connection with the assignment and transfer of the Franchise to SCS Communications and Security, Inc., the Council certifies that:
 - a. The Franchise was duly and validly issued by the City and upon its assignment to SCS Communications and Security, Inc., the duly authorized franchisee will be SCS Communications and Security, Inc.
 - b. The Franchise is in full force and effect as of the date hereof and is valid and enforceable in accordance with its terms.
 - c. No event of default under the Franchise, and no event which could become an event of default with the passage of time or the giving of notice, or both, has occurred and is continuing as of the date hereof.
 - d. All the fees owing the City pursuant to the Franchise have been paid through March 31, 1995. The next quarterly payment is due June 30, 1995.

5.	This Resolution shall take effect upon the execution of the Acknowledgment of Transfer by authorized representatives of Northland Cable Properties Eight, Inc. and SCS Communications and Security, Inc., attached hereto as Exhibit A.
