- 1. **Nature of Application:** The application is to vacate the alley between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets.
- 2. **Summary of Findings:** The City Council determine vacating the alleyway would not prejudice the public interest.
- 3. **Decision and Conditions of Approval:** The application was approved with a public utility easement to be granted to the city to maintain and access utilities.
- 4. **Appeal Right:** The Commission's action may be appealed within 14 days of the mailing of this notice. An appeal to the City Council may be filed with the Director of Community and Economic Development pursuant to Stayton Municipal Code 17.12.110.
