- 1. **Nature of Application:** The application is to vacate the alley between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets.
- 2. **Summary of Findings:** The Planning Commission found that the application met the standards for approval.
- 3. **Decision and Conditions of Approval:** The application was approved for recommendation by the Planning Commission with a public utility easement to be granted to the city to maintain utilities.
