- 1. **Nature of Application:** The application is for Site Plan Review Site Plan Review for an 820 square foot addition to the existing orthopedic group clinic with a variance application for off-street parking and loading, bicycle Parking, and landscaping and screening requirements on an already developed industrial .38-acre site in Public/Semi Public (P) zone.
- 2. **Summary of Findings:** The Planning Commission found that the application met the standards for approval, with noted exceptions.
- 3. **Decision and Conditions of Approval:** The application was approved by the Planning Commission with three conditions plus standard conditions of approval for land use applications.
- 4. **Appeal Right:** The Commission's action may be appealed within 14 days of the mailing of this notice. An appeal to the City Council may be filed with the Director of Community and Economic Development pursuant to Stayton Municipal Code 17.12.110.
