SUBJECT: Application for Vacation of Alleyway between N First Avenue and N Second Avenue, Running from E Pine to E Fir Streets

ISSUE

The issue before the Planning Commission is a public hearing on an application to vacate an alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets.

BACKGROUND

The alleyway requested is shown below, in a 2023 aerial photo:



Signatures were obtained from two-thirds of property affected by the vacation of the alleyway. See the table below including addresses, property owner, size of parcel and whether they signed the petition.

The Community and Economic Development Department did receive two comments from agencies and no comments from the general public. SCTS sent comments that they have existing facilities that service First Avenue within the easement and would require access to them. Astound Broadband responded that they had no comments regarding the alleyway vacation.

The Planning Commission did approve an alleyway vacation directly south of the proposed alleyway vacation. The Planning Commission approved the vacation of the alleyway between N First Avenue and N Second Avenue, running from E Pine to E Hollister Streets on July 31, 2023.

ANALYSIS

This report presents the Planning Staff's summary and analysis concerning this application. Attached is an application from James Baxter requesting the City to vacate the alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets.

State law requires the application include the signatures of the owners of property adjacent to the right-of-way proposed for vacation and the signatures of owners of two thirds of the "affected land." This application includes the signatures of two-thirds of the owners of the properties affected by the vacation.

Vacation of alleyways is not included in Chapter 17.12 of the Land Use and Development Code; therefore there are no criteria in the Code that the Planning Commission must determine are met. The role of the Planning Commission in this case is advisory to the City Council. ORS 271.120 provides that the City Council may grant the request for vacation "if they find the public interest will [not] be prejudiced."

There is an existing utility located within the alleyway proposed to be vacated. The proposed draft order suggests a public utility easement with the alleyway for access, and maintenance of all utilities within the alleyway with the cost of the easement, preparation of the easement, and recording incurred by the applicant.

The staff recommendation is for the Planning Commission to recommend that the City Council vacate the alleyway with the granting of a utility easement to the City of Stayton.

RECOMMENDATION

The staff recommendation for approval with conditions is reflected in the draft order that is attached to the staff report.

There may be testimony at the public hearing that requires the draft order be modified to reflect that testimony.

OPTIONS AND SUGGESTED MOTIONS

Staff has provided the Planning Commission with a number of options, each with an appropriate motion. The Planning Department recommends the first option.

1. Recommend to the City Council that the alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets, be vacated, adopting the draft order as presented.

I move the Stayton Planning Commission to recommend to the Stayton City Council that the alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets be vacated and adopt the draft order presented by Staff.

2. Recommend to the City Council that the alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets be vacated, adopting modifications to the draft order.

I move the Stayton Planning Commission to recommend to the Stayton City Council that the alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets, be vacated and adopt the draft order with the following changes...

3. Recommend to the City Council that the alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets, not be vacated, directing staff to modify the draft order.

I move the Stayton Planning Commission to recommend to the Stayton City Council that the alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets be vacated and direct staff to and bring a revised draft order for Planning Commission approval at the June 30, 2025, meeting.

4. Continue the hearing until June 30, 2025.

I move the Stayton Planning Commission continue the public hearing on the application to vacate that the alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets until June 30, 2025.

5. Close the hearing but keep the record open for submission of written testimony.

I move the Stayton Planning Commission close the hearing on the application to vacate that the alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets but maintain the record open to submissions by the applicant until June 3, allowing 7 days for review and rebuttal and then an additional 7 days for the applicant to reply, with final closure of the record on June 30, 2025.

6. Close the hearing and record and continue the deliberation to the next meeting.

I move the Stayton Planning Commission continue the deliberation on the application to vacate that to vacate that the alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets until June 30, 2025.

RECOMMENDATION OF APPROVAL

I. NATURE OF PROCEEDINGS

The proceedings are for a request to vacate the Alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets. A petition requesting the City vacate the right of way was submitted by James Baxter who lives at 1435 N 2nd Avenue.

II. PUBLIC HEARING

A public hearing was held on the proposal before the Stayton Planning Commission on May 25, 2025. At that hearing the Planning Commission reviewed Land Use File # 05-02/25 to vacate the Alleyway and made it part of the record. At the public hearing there was testimony from the applicant. The Planning Commission has considered their testimony in the findings and conclusions below.

III. FINDINGS OF FACT

- 1. James Baxter is the owner of 1435 N 2th Avenue. Ms. Looper has submitted a petition requesting the City vacate the Alleyway between N First Avenue and N Second Avenue, running from E Pine to E Fir Streets.
- 2. The petition was accompanied by the signatures of the owners of five of the seven parcels adjacent to the alleyway proposed for vacation. The signatures meet the requirement of the obtaining two-thirds of the property "affected" by the proposed vacation.
- 3. SCTC has facilities feeding the N First Avenue lots and will need a utility easement to provide and grant access before vacation to the alleyway.

IV. PUBLIC COMMENTS

The Planning Department received comments prior to the public hearing from SCTC and Astound Broadband.

V. ORDER

Based on the findings of fact, the Planning Commission voted on May 25, 2025, to recommend to the City Council that the Alleyway be vacated with a public utility easement to be granted to the city to maintain utilities.
