

ISSUE

The issue before the Council is should the City award a construction contract to Black Pearl Paving and Excavation for the West Ida Street Sanitary Sewer Replacement project?

BACKGROUND INFORMATION

In 2020 the City hired Keller Associates to perform Wastewater Facilities Planning Study (Master Plan) for the City's wastewater system. The Wastewater Facilities Planning Study was adopted by the City Council in February 2021. The planning study looks at the impacts of growth over a 20-year period and identifies areas where growth is most likely to occur. The study identified deficiencies in the sanitary sewer system. A priority list of projects was created and is shown in Table 12.1 in the Wastewater Facilities Planning Study document (master plan).

The Priority 1 project includes upsizing a 24-inch sanitary sewer pipe to a 30-inch pipe. The project starts in Jetters Way at an existing sanitary sewer vault, located just west of the Stayton Fire Department, thence north to Ida Street, thence east to Evergreen Avenue, thence north to the bridge over the Salem Ditch. The length of the entire Priority 1 project is 4,800 linear feet.

The contract before you is for construction of Phase 1 of the Priority 1 project, which includes the first 2,100 linear feet of the Priority 1 project. It will start at the sanitary sewer vault and will terminate at a manhole in Ida Street located just south of 1207 Ida Street.

The formal bid packet including the design and specifications for the sanitary sewer project was developed by City staff, which included the Public Works Director, City Engineer, Senior Engineering Technician, and an engineering consultant who designed the improvements.

The project was originally advertised in July 2022 with a bid opening of August 18, 2022. The City did not receive any bids, so we postponed the project until after the new year.

The project was re-advertised competitively in the Daily Journal of Commerce and sealed bids were opened on January 5th, 2023, at 2:00 PM.

The City received six (6) bids as shown in the following table:

Black Pearl Paving and Excavation of Roseburg, Oregon was the apparent low bidder.

Each bidder was responsible for submitting 2 job references for work performed by the contractor that was similar in size and scope to the W. Ida Street Sanitary Sewer Replacement Project. Staff interviewed the agencies that worked with the Black Pearl Paving and Excavation and determined agencies were satisfied with work performed.

Staff then interviewed the owner of Black Pearl Paving and Excavation to get a sense of their process, the resources they would be dedicating to the project, and their overall experience with this type of project. The interview team came away from the meeting comfortable with a recommendation to award the contract to Black Pearl Paving and Excavation.

STAFF RECOMMENDATION

City Staff reviewed the bids, interviewed past clients of Black Pearl Paving and Excavation, and conducted an interview of the owner of Black Pearl Paving and Excavation and we are confident that they can perform the work as shown in the construction plans. Staff Recommends awarding a contract for the W. IDA Street – Sanitary Sewer Replacement Project – Phase 1 to Black Pearl Paving and Excavation in the amount of \$1,768,841.55.

BACKGROUND INFORMATION

The Santiam Teen Center is operated by New Growth Ministries on City-owned property at 2800 Kindle Way. This is the location of the future Mill Creek Park. The City obtained the property, which included the existing 2,100 square foot manufactured home, in 2017. The City subsequently began developing a plan for ultimate development of the park.

In 2019 the City completed the Mill Creek Park Master Plan which envisioned a variety of park amenities and assumed the ultimate removal of the manufactured home. During the time the plan was being developed, the New Hope Ministries approached the City about allowing the use of the structure for a teen center.

After discussion and negotiations, the City entered into an MOU and lease agreement with New Hope Ministries to operate a Teen Center with the understanding that it could not be used for "the promulgation of religious doctrine." The lease payment is \$1 per year, and it is assumed that this rate was based on the fact that the Teen Center was considered a public benefit, that the lease allows the City to terminate the lease with 30 days' notice, and is also the reason for the specificity that it was not to be used for "promulgation of religious doctrine."

The MOU was signed 12/18/17 and the lease agreement was signed 4/3/18. The Lease was a 3-year term which technically expired 4/3/21, however current staff was unaware of the expiration until 2022. Staff has prepared the attached issue paper to provide additional background information on issues that need to be

considered or taken into account before we determine whether to renew the lease and, if so, what the terms of the lease are.

Ultimately, staff will be asking for Council input on two primary questions at this time:

- QUESTION #1: Is there an interest in renewing the lease for the Teen Center?
- QUESTION #2: Is there an interest in discussing the possibility of the Teen Center remaining on the property in its current or an alternate location as part of an update to the Mill Creek Neighborhood Park Plan?

Once the answer to those questions is understood, additional input on the terms of the lease will be requested. For example: Would the City want to see the facility open more hours? Would the City want it open/available for other uses similar to a community center? Would we entertain allowing the operator to allow for reservations for other groups or require that it only be utilized as a Teen Center? Would we remain willing to allow its use for the \$1 annual rent?

Background

Current use

New Hope Ministries constructed about \$25,000 worth of improvements to the building in order to use it as the Teen Center. These included an interior partition wall and ramps for handicap access. The Teen Center opened in 2019.

The Teen Center currently operates 3 days a week from 3:00pm to 6:00pm, serving 7th to 12th graders. On average, the Center hosts approximately 10-20 teens per day. There are also ____ volunteers and a full-time executive director. The Teen Center director participates on the North Santiam SIT and reports



that, in addition to providing a refuge for teens, they also have laundry facilities which have been made available to families in need. It appears that they are a valuable resource for teens and families in need in the community as well as a good outlet for all teens that want a safe and entertaining environment to hang out after school.

Mill Creek Park Plan

The Mill Creek Neighborhood Park was identified in the 2004 Stayton Parks and Recreation Master Plan. In 2017, the City purchased 23 acres for a future park and open space which was adjacent to property



shown in the 2004 master plan. The hired City а consultant to prepare a master plan of future park 2018 in and 2018between 2019 the community helped develop the plan for the park. At the time of the

master planning for the park, it was not assumed that the house would stay on the property once development of the park began. The plan shows that the manufactured home that the Teen Center is using is not on the property and a playground in the general vicinity of the structure.

The City has applied to the Oregon Parks and Recreation Department for grant funds to support construction of the Mill Creek Park, but has not yet been successful in receiving funding. The City will continue to submit applications for park development funds, but when construction of the park will commence remains unknown.

Aquifer Storage Recovery

In 2019, City began exploring alternatives for a secondary source of drinking water supply that is not directly dependent on the North Santiam to increase the City's supply resiliency. The study confirmed that developing a reliable groundwater source from the Columbia River Basalt Group aquifer is not possible because the City is located within the Stayton-Sublimity Groundwater Limited Area, and groundwater levels in the basalt aquifer system have been declining regionally. ASR was identified as the most favorable potential redundant supply to further evaluate.

In 2020, the City received funding from the Oregon Water Resources Department (OWRD) to evaluate the feasibility of developing an ASR system. The study feasibility involved identifying potential sites for an ASR well, drilling and testing an exploratory well, and evaluating water availability and water quality. The study concluded that ASR is a feasible option to supply the City with a



much-needed redundant water supply, with the capability of helping meet peak demands in the summer as the City grows. It was determined that the most suitable location for the facility was on the Mill Creek Park site. As shown in the diagram above, the location is generally in the vicinity of the area designated as a future parking lot in the park master plan. The City recently learned that we were awarded \$3.8 million toward construction of the project from the OWRD. The City will need to update the Mill Creek Park Plan to accommodate the ASR facility, which will consist of the well and a small building to house pumps and controls.

Questions

QUESTION #1: Is there an interest in renewing the lease for the Teen Center?

QUESTION #2: Is there an interest in discussing the possibility of the Teen Center remaining on the property in its current or an alternate location as part of an update to the Mill Creek Neighborhood Park Plan?
